The Ministry responsible for European Funds would like to announce that it is launching two calls for project proposals in the following area:

Priority 1: PO 1 - A more competitive and smarter Europe by promoting innovative and smart economic transformation and regional ICT connectivity

RSO1.2 – Reaping the benefits of digitalisation for citizens, companies, research organisations and public authorities (ERDF)

The calls shall target investments as indicated below:

Call 19 shall focus on the Digitalisation of Public Administration and Entities;

Call 20 shall focus on the Digitalisation of the Health sector.

These calls shall be open to Ministries, Government Departments and Public Sector entities and shall close on **30th September 2024 at 16:00**.
