The Ministry responsible for EU Funds would like to pre-announce the following call under the Common Agricultural Policy Strategic Plan 2023-2027:

Setting up of young farmers (Instal 75)

This intervention supports young farmers below 41 years of age at the time of application, by providing start-up aid in the form of a lump sum to help implement a business plan focused primarily on agricultural activities. Secondary activities related to product processing can also be included.

The goal is to help young farmers establish themselves as heads of agricultural holdings.

The actual launch of the call, together with details of information sessions, the application form and other supplementary documentation, will be published in November 2024 and can be obtained from <https://fondi.eu>. This call is expected to close in March 2025.
