COMMON AGRICULTURAL POLICY STRATEGIC PLAN FOR MALTA
2023-2027**

The Ministry responsible for EU Funds is pre-announcing the following call under the Common Agricultural Policy Strategic Plan 2023-2027:

Intervention 77.2 Cooperation EIP Operational Groups

This intervention aims to grant support for the cooperation among supply-chain actors and support for pilot projects.

Support under this intervention must contribute to one of the following actions:

- Support for horizontal and vertical cooperation among actors for the establishment and development of short-supply chains and local markets.
- Support for co-operation for sustainable provision of biomass (for use in food and energy production and industrial processes (waste)).
- Support for pilot projects, and for the development of new products, practices, processes and technologies.
