COMMON AGRICULTURAL POLICY (CAP) STRATEGIC PLAN FOR MALTA
2023-2027**

The Ministry responsible for EU Funds is pre-announcing the following call under the Common Agricultural Policy Strategic Plan 2023-2027:

Intervention 73.2 Off-Farm Non-Productive Investment and Afforestation

This intervention aims to support Government Authorities and entities to invest in afforestation projects across the Maltese Islands. The support offered may include:

1. Actions that promote the planting of trees, ancillary works, and improving the resilience and environmental value of forest ecosystems
2. Actions that promote the removal of invasive alien tree species
3. Actions that promote the rehabilitation of valleys around the Maltese Islands

Eligible applicants are Government Authorities and entities.

The actual launch of the call, together with details of an information session, the Application Form and other supplementary documentation will be published in January 2025 and can be accessed at <https://fondi.eu/>. The first batch of this call is expected to close in March 2025.
