**Knowledge Exchange and Dissemination of Information
Intervention 78.1.2 Support for short-term farm management exchange as well as
farm visits**

This intervention aims to improve the basic skills and knowledge primarily amongst farmers, as well as possibly among the individuals working in the agri-food sector by supporting exchange visits to improve knowledge and understanding.

Eligible applicants for this intervention will be public authorities having the necessary expertise within the agricultural sector.
