PRE-ANNOUNCEMENT OF CALL FOR PROJECT PROPOSALS UNDER ASYLUM, MIGRATION AND INTEGRATION FUND (AMIF) 2021-2027

The Ministry responsible for European Funds would like to pre-announce the following call under the Asylum, Migration and Integration Fund (AMIF):

Specific Objective 2: *strengthening and developing legal migration to the Member States in accordance with their economic and social needs, promoting and contributing to the effective integration and social inclusion of third country nationals.*

The envisaged call shall cover one of the following funding priorities:

- reducing language barriers in schools to facilitate integration among children;
- promoting diversity in the educational sector to address current and future needs of society;
- cultivating ethnicity in the social and educational sectors; and
- provision of support services to migrant families to facilitate access in the education system.

The call will be launched on 19th May 2025 and it will close on **31st July 2025 at noon**.

The application form, details of eligibility and indicator guideline notes will be made available with the launch of the call. Prospective applicants are encouraged to refer to the AMIF Programme available [here](#) in order to check whether their proposals are eligible for funding through this call for project proposals.

Il-Ministeru responsabbli mill-Fondi tal-Unjoni Ewropea jixtieq javża li ser tiġi mnedja s-sejħha għall-proposti ta' proġetti li jaqgħu taħt I-Fond ghall-Ažil, il-Migrazzjoni u l-Integrazzjoni (FAMI):

Objettiv Specifiku 2: *it-tisħiħ u l-iżvilupp tal-migrazzjoni legali lejn l-Istati Membri f'konformità mal-ħtiġijiet ekonomiċi u soċjali tagħhom, u l-promozzjoni u l-kontribuzzjoni għall-integrazzjoni effettiva u l-inklużjoni soċjali ta' cċittadini ta' pajjiżi terzi.*

Din is-sejħha għall-proposti għandha tkopri azzjoni li tiffoka fuq:

- jitnaqqsu l-ostakli lingwistiċi fiskejjel biex tiġi ffacilitata l-integrazzjoni fost it-tfal;
- il-promozzjoni tad-diversità fis-settur edukattiv li jindirizza n-nuqqasijiet attwali u l-ħtiġijiet futuri tas-soċjetà
- trawwim t'etniċità fis-setturi soċjali u edukattiv; u
- provvista ta' servizzi ta' sostenn lill-familji migranti biex jiġi ffacilitat l-aċċess fis-sistema edukattiva.

Is-sejħha għall-proposti ser tiġi mnedja fid-19 ta' Mejju 2025 u tibqa' miftuħha sa' **nofsinar tal-31 ta' Lulju 2025**.

It-tnedija tas-sejħiet, flimkien mal-formola tal-applikazzjoni u d-dokumentazzjoni supplimentari ser ikunu disponibbli mat-tnedija tas-sejħha għall-proposti.
