COMMON AGRICULTURAL POLICY (CAP) STRATEGIC PLAN FOR MALTA
2023-2027**

The Ministry responsible for EU Funds is pre-announcing the following call under the Common Agricultural Policy Strategic Plan 2023-2027:

Intervention 73.1 On-Farm Non-Productive Investment (Afforestation)

This intervention aims to support farmers and group of farmers that invest in afforestation on their land. The support offered can include:

1. Actions that promote tree planting and ancillary works for purposes of agri-environmental and climate objectives, including tree planting for soil management and erosion control action
2. Actions that promote the removal of invasive alien tree species

Eligible applicants are farmers
