

ESF+ Programme

- A total of Five Priorities are financed through ESF+ funds
- Priorities 1 to 5 funded under ESF+ with key priority areas including:
- ☐ Priority 1: Enhancing employability and labour market resilience;
- □ Priority 2: Fostering active inclusion for all;
- ☐ Priority 3: Quality and inclusive education and enhanced lifelong learning for growth;
- ☐ Priority 4: Addressing material deprivation; and
- ☐ Priority 5: Enhancing social innovation.

The applicable **co-financing rate** for the 2021-2027 Programme is:

60% EU share and 40% MT share




Call for Project Proposals

Priority: 2. Fostering active inclusion for all

- Specific objective: **ESO4.11. Equal access to quality social and healthcare services**
- Open call Eligible applicants include: Government departments, public entities, social partners, Non-Governmental Organisations and voluntary organisations.
- Budget Allocation for Call 16 is **€9,325,665.81**
- Co-financing rate of 60% EU Share & 40% MT Share
- Deadline for submission: 20th October 2025









Application process

- The application will include but not limited to the following critical information:
 - General details on the applicant organisation and partners
 - The applicable specific objective, expected results and added value
 - The targeted cohorts and the related indicators
 - Financial plan and the activities being proposed
 - Publicity
 - Horizontal Priorities
 - Financial Sustainability



Selection Process

- The selection process is carried out by the Project Selection Committee (PSC).
- The PSC will rank the project proposals. A minimum score of 50% must be obtained.
- If an applicant wishes to proceed with a grievance on the outcome of the PSC, then the applicant may send a request of appeal to the **Project** Selection Appeals Board.

Output	Result
Measure the direct deliverables of a project	Measure the effects of a project (the change)
They record the point of entry of participants at the start of the Project.	For project participants, they record the situation at the end of the Project (ex: 4 weeks / 6 months after)
