

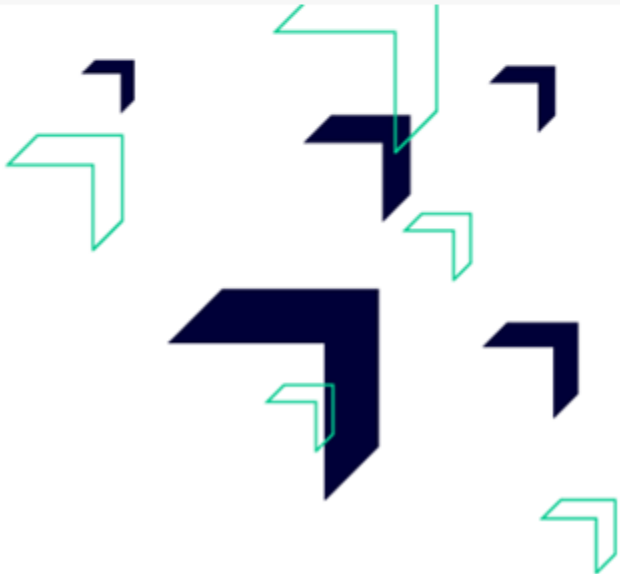

INTERVENTION DETAILS

Scheme Budget: €300,000 in total (public expenditure)

Support rate: 50% of the eligible costs up to a maximum grant value of €15,000 for each project (This may be increased to 65% for certain categories of farmers)

Deadline: 28th January 2026 at 12:00hrs (noon)

Maximum Duration of the project: 15 Months from the date of award letter

The call is open for **On-Farm Productive Investments** related to:

- ✓ Investment in Vineyard Renewal and Development;
- ✓ Must follow European Union wine quality standards (DOK and IGT)

ELIGIBLE APPLICANTS

Support under this intervention is available to:

- ✓ Farmers, whether natural or legal persons (including Group of Farmers like partnerships and cooperatives), who:
 - are registered as farmers on the Department of Agriculture database (IACS);
 - are registered as farmers with Jobsplus;
 - have a VAT number.

ELIGIBLE APPLICANTS

Support under this intervention is available to:

- ✓ Restrictive Investment Proposal
 - ✓ Establishment of vineyards if 1 Tumolo (0.112 Hectares) of vines or more are included;
 - ✓ **It must be on a continuous parcel, regardless of vine variety**



FUNDING RATES

- New Vineyard - €32,825 per Hectare
- Vineyard Renewal (uproot & replant) - €35,384 per Hectare;
- 7% Indirect cost
- **Indirect Cost is within the €15,000 Grant Value**
- **No Standard Output (SO) checks required for such applications.**



WHAT YOU NEED

- At application stage:
 - Consultancy Service
 - Consultant must be registered with Farm Advisory System (FASRB)
 - <https://arpa.gov.mt/en/farm-advisory-system-fas/>
 - Letter of Intent from a Licenced Winery.
 - Winery letter must show:
 - Vine variety
 - Compliance with DOK and IGT
 - Tax Compliance Certificate – Issued not earlier than (3) months from the date of application
- At project stage:
 - 4 Hour Training Module relevant to this intervention.

Expenditure is considered to be eligible expenditure and therefore eligible for reimbursement only if it has been incurred after an application has been submitted to the Managing Authority

ELIGIBLE COSTS

- Conversion to grape varieties that are recognised under DOK or IGT, or which improve the market potential of the vineyard;
- Vineyard restructuring including:
 - Move vineyards to more suitable plots and/or
 - Changes to planting patterns, row orientation, and training system to improve productivity, quality, or compliance;
- Replanting following compulsory uprooting ordered due to plant health or phytosanitary issues, provided this verified and documented by the consultant/viticulturist;
- Clearly demarcated extensions to vineyards in same parcels will be considered as new vineyards.

INELIGIBLE COSTS

- Restructuring or replanting single rows only rather than full, continuous parcels;
- Actions that alter existing vineyard in a way that does not increase the surface area (example: filling the gaps by re-planting dead vines) and that do not extend the vineyard area;
- Work needing Planning Authority Permit and which permits to perform work (valid and executable) are not in hand at the time of application;

PAYMENT PROCEDURE

- Interim Payment of 40% of Grant Value – Proof Showing the purchase or order of vine plants
- Finaly Payment of 60% of Grant Value – Upon completion of project and submission of required documentation
 - Proof of Training attendance
 - Proof of Registration within the National Vineyard Registry
 - Compliance report by consultant/viticulturist

CHANGE REQUESTS

- Projects shall be limited to two (2) change request submissions.

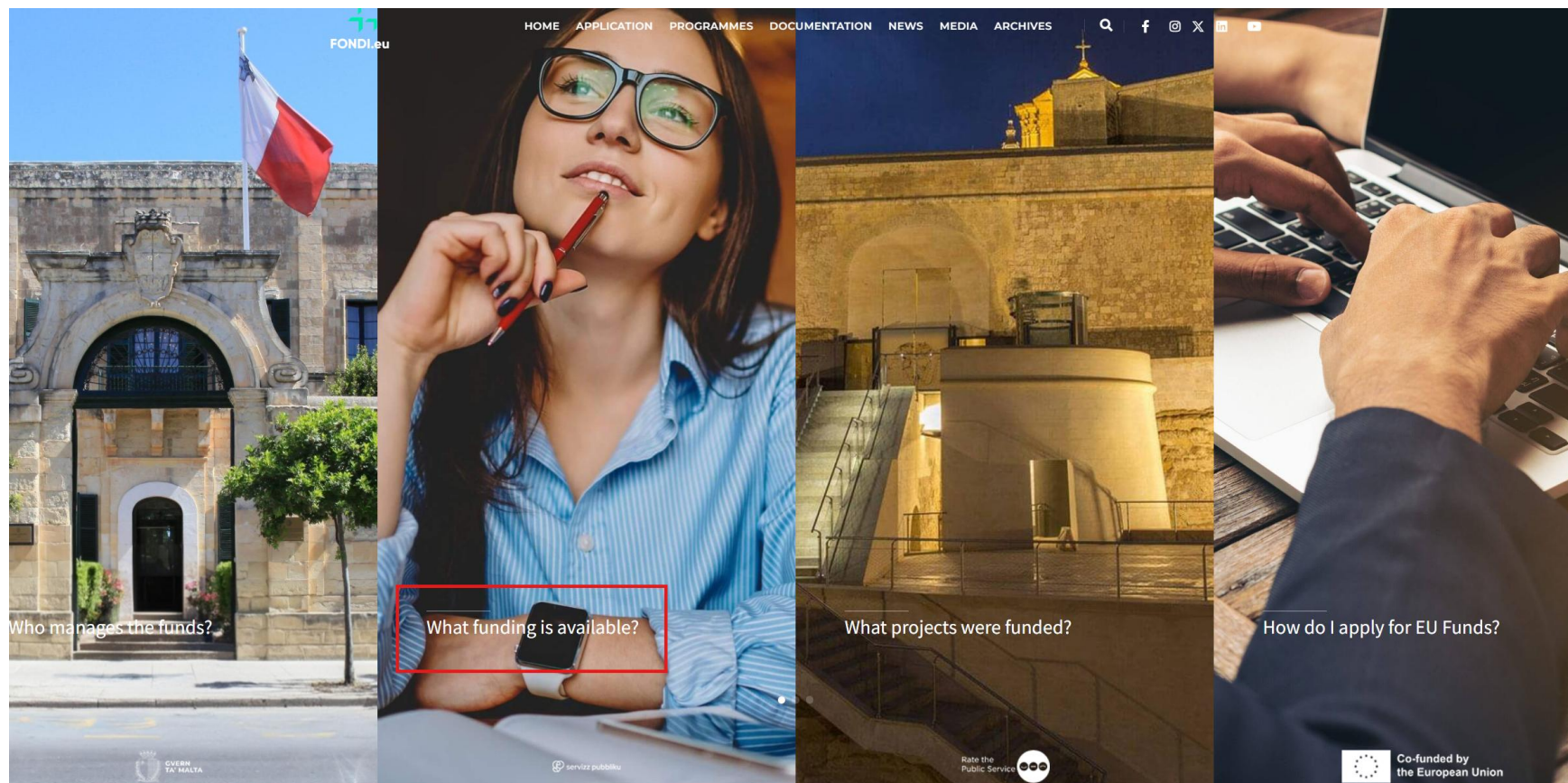


DURABILITY

- ✓ Projects receiving a grant up to **€15,000** , they must **keep and use that investment properly for at least one year** after they receive the final payment.


