The Ministry responsible for EU Funds is pre-announcing the following call under the Common Agricultural Policy Strategic Plan 2023-2027:

**On Farm Productive Investments Intervention – Combined  
I73.5 & I73.5.1**

This intervention aims to grant support for investment in agricultural holdings, focusing on the entire territory of Malta.

Eligible applicants are farmers, whether natural or legal persons, who are registered with the Agriculture Directorate, or Group of Farmers (including inter alia partnerships, cooperatives).

The actual launch of the call, together with details of information sessions, the Application Form and other supplementary documentation will be published in February 2026 and can be obtained from <https://fondi.eu/>. This call is expected to close by end of April 2026.
