PRE-ANNOUNCEMENT OF CALL FOR PROJECT PROPOSALS UNDER Internal Security Fund 2021-2027

The Ministry responsible for European Funds would like to pre-announce the following call under the Internal Security Fund (ISF):

Specific Objective 3: supporting the strengthening of Member States' capabilities in relation to preventing and combating crime, terrorism and radicalisation, as well as managing security-related incidents, risks and crises, including through increased cooperation between public authorities, relevant Union bodies, offices or agencies, civil society and private partners in different Member States.

The proposed call will contribute to the funding priority of *'enhancing the capabilities of law enforcement authorities and other key stakeholders to effectively prevent and tackle hate crime and hate speech, through the delivery of targeted training programmes and the establishment and improvement of mechanisms that facilitate the reporting and identification of victims.'*

The call will be launched on **18th September 2026**, and it will close on **12th February 2027 at noon**.

The application form, details of eligibility and indicator guideline notes will be made available with the launch of the call. Prospective applicants are encouraged to refer to the ISF Programme available on <https://fondi.eu/wp-content/uploads/2026/01/ISF-MT-Programme-v.3.0.pdf> in order to check whether their proposals are eligible for funding through this call for project proposals.

PRE-AVVIŻ TA' SEJHIET GHAL PROPOSTI TA' PROĠETTI TAHT IL- FOND GĦAS-SIGURTÀ INTERNA (FSI) 2021-2027

Il-Ministeru responsabbli mill-Fondi tal-Unjoni Ewropea jixtieq javża li ser tiġi mnedija s-sejha għall-proposti ta' proġetti li jaqgħu taht l- Fond Għas-Sigurtà Interna (FSI):

Objettiv Speċifiku 3: li jappoġġa t-tisħiħ tal-kapaċitajiet tal-Istati Membri fir-rigward tal-prevenzjoni u l-ġlieda kontra l-kriminalità, it-terroriżmu u r-radikalizzazzjoni, kif ukoll il-ġestjoni ta' incidenti, riskji u kriżijiet relatati mas-sigurtà, inkluż permezz ta' kooperazzjoni akbar bejn l-awtoritajiet pubbliċi, il-korpi, l-uffiċċji u l-aġenziji rilevanti tal-Unjoni, is-soċjetà ċivili u s-sħab privati fi Stati Membri differenti.

Is-sejha proposta se tikkontribwixxi lejn il-prijorità ta' finanzjament relatata mat-*'titjib tal-kapaċitajiet tal-awtoritajiet tal-infurzar tal-liġi u ta' partijiet interessati ewlenin oħra sabiex jipprevjenu u jindirizzaw b'mod aktar effettiv ir-reati u d-diskors ta' mibegħda, permezz tat-tweqqif ta' programmi ta' taħriġ immirati u l-istabbiliment jew it-titjib ta' mekkaniżmi li jiffaċilitaw ir-rappurtar u l-identifikazzjoni tal-vittmi.'*

Is-sejha ser titnieda fit-**18 ta' Settembru 2026** u tagħlaq fit-**12 ta' Frar 2027** f'nofsinhar (12:00).

It-tnedija tas-sejhiet, flimkien mal-formola tal-applikazzjoni u d-dokumentazzjoni supplimentari ser ikunu disponibbli mat-tnedija tas-sejha għall-proposti.
