Call III - closed



- ▶ Call III targeted PA 4, PA 7, PA 10 & PA 11 and the deadline was 2nd December 2016 for PA 4 and 27th January 2017 for the rest of the PAs.
- It was open for project proposals to be undertaken by Ministries, Government Departments, Central Government Authorities and the Public Sector Companies







▶ Call IV was launched on 27th November 2016 and closed on 5th May 2017. It was open for Local Councils, NGOs and Cultural Organisations having public interest and targeted PA 4 and PA 5 projects

Evaluation is well underway and 5 PSC sessions have already been held



Evaluation is being carried out on the basis of a Policy-Led Multi Criterion Analysis.

Call V - Ongoing



- ▶ Call V was launched on 25th June 2017 and closed on 29th September 2017;
- ▶ This call targets projects under PA 1 *Investing in research, technological development and innovation*.
- It was open for Ministries, Government Departments, Public Sector and Public Institutions which are in line with the priorities identified in the RIS3 strategy and supporting documents.




- ▶ Call VI was launched on 25th June 2017 and will close 17th November 2016.





Aid Scheme

- ▶ The Aid Scheme (E-Commerce Grant Scheme) is aimed to assist undertakings to part-finance investment to develop or upgrade an ecommerce website and/or mobile application that enables online payments or booking systems through the integration of an online payment gateway.
- The maximum grant capped at €5,000, part financing eligible expenditure up to 50%
- The scheme is being implemented through open rolling calls with 5 cut off dates. To date:
 - > 36 applications were submitted out of which
 - **14 grants** were approved with a total value of €67,000





 - redeveloping and creating a centre of excellence for traditional Maltese artisans operating in the manufacturing of traditional Maltese goods and crafts (Ta Qali Crafts Village Project);
 - transferring business activities away from the village core, enabling further economic growth through better diversification in the economy, and to provide further job opportunities for people living in Gozo (Xewkija Industrial Estate).



Approved Projects



Five projects were approved with a total value of **€20.7M** aimed at:

- Promoting renewable energy sources in the domestic sector and provides financial support to cover the costs of PV systems (RES Scheme)
- Building capacity to generate electricity from solar energy to be used by the MITA Data Centre
- Upgrading existing street lighting with energy efficient lights covering ca.
 79.6 km of roads (Street Lighting Project)
- Introducing an energy efficient system for St Vincent de Paul Residence including heating, ventilation and air-conditioning systems aimed at reducing energy consumption. (SVDP Project)
- Upgrading and retrofitting the Gozo Administration Centre to reduce energy consumption.

Implementation Progress – RES Scheme



- ▶ 4165 households in over 68 localities will benefit from financial support to undertake investment in RES. Total investment of €30.1M of which €9.1M represent the EU support
- ≥ 2916 payments were issued, amounting to circa €6.4M
- Additional PV connected capacity resulting in a capacity of renewable energy production of 9487kWp




Estimated annual decrease in GHG of 10,961,754 kg





Investment Priority 6c

• Improve the urban environment in the Southern Harbour in line with the preservation and promotion of cultural/ historical assets in the public domain intended to improve employment opportunities in social deprived areas.

Investment Priority 9b

 Regeneration of public open spaces and public social housing within deprived neighbourhoods to lift people out of risk of poverty. In addition, this investment priority will be supported through infrastructure in education / community centres which will be complimented by ESF type of measures.

Through investment under these IPs, there should be:

- An increase in the expected number of visits to supported sites of cultural or natural heritage and attractions.
- An area of constructed heritage upgraded or renovated in urban areas.



Overview

- Sustainable Urban Development projects are national projects that will be implemented in accordance with the integrated urban development strategies
- No public call for applications will be issued for the selection of these projects.
- ▶ The Coordination Committee for Sustainable Urban Development (COCOSUD) will decide on the allocation of funds for the different interventions taking into account the integrated urban development strategies.
- ▶ The MA will retain the right of the final verification of eligibility of operations before approval.


Status Update



- ▶ Finalisation of JASPERS assistance for the development of a Multi Criteria Analysis (MCA) that makes use of scenarios to be applied to the draft strategy
- MCA confirmed that the combination of investment priority areas chosen are expected to maximise the benefits within the area
- Launching of Priority Axis 6 at national level Coordination Committee for Sustainable Urban Development set up
- Committee Objective : to identify list of operations in line with OPI requirements by November 2017
- Next steps: conclude Committee deliberations; finalise draft strategy


• Infrastructural investment in collective public transport to increase patronage through: multi-modal transport including sea landing spaces, investment in green public transport, information systems, greening of public spaces in urban areas as well as campaigns earmarked to influence behavioural patterns will be supported. These actions will contribute towards better air quality.

Through investment under this IP, there should be:

- Number of persons reached by campaigns or actions intended to promote modal shift; and
- Actions intended to decrease greenhouse gas emissions from the transport sector.

PA 7 Status



One mainstream project was selected in November 2017 with a total value of €28.5M aimed at:

- encouraging a modal shift from private car use to collective, sustainable & alternative low-carbon transport modes
- introducing the concept of local transport hubs
- addressing current traffic congestion on selected critical public transport bus corridors
- deploying a number of intelligent CCTV cameras to monitor and detect barriers.








Architectural rendering of the Paola Regional Medical Hub





- By end 2016 all works related to the diversion routes were completed. As at October 2017, 85% of the project has been complete
- The major remaining works relate to the laying of services and formation of roads in the San Gwann and Gzira sides of the junction, closing off the final asphalt works in the slip road towards Sliema Road Gzira and the re-construction of the University Underpass






PA 3 (IP3d) – following a preliminary ex-ante assessment and taking into consideration the uptake of the SME Initiative, it was decided to consolidate the implementation of the guarantee instrument through the SMEi dedicated programme.

PA 4 (IP4b) – the ex-ante assessment required for the setting up of a Financial Instrument is in its initial stages. Discussions with EIF are ongoing and the main stakeholders were interviewed. Surveys with the domestic and commercial sector are to be held by end of year.







Follow-up to Peer Review Meeting



Following the peer-to-peer review meeting held between 4th and 5th May 2017 with representatives from DG REGIO, DG EMPL, Key Experts, the Managing Authority (MA), as well as members from the Ismeri Europa team,

- ➤ the MA is currently carrying out an internal assessment to review the Evaluation Plans which will be discussed with DG Regio Evaluation Unit at the beginning of December 2017.
- ➤ The ToRs of the Counterfactual Impact Evaluation will be revised on the basis of the outcome of the meeting.
- ➤ The amendments to the Evaluation Plans will be presented to the European Commission in Q4 2017, and these will include changes mainly to the timing of the evaluation, thematic areas and further assessment of the availability of data.




Other Evaluation Activities

Annual Activity 2017






Capacity Building Activities in 2017

Update on Implementation: N+3 Disbursement 2017






Update on Implementation: N+3 Disbursement 2017



N+3 Disbursement Targets 2017 ERDF Status Update (€millions)




