#### **Legal Basis**

- Regulation (EU) No 1303/2013 of the European Parliament and of the Council
- Commission Delegated Regulation (EU) No 240/2014
- In line with Article 47 of Regulation (EU) No 1303/2013, Malta will set up a single Monitoring Committee for the Operational Programme I and the SME Initiative OP and a Monitoring Committee for the Operational Programme II.



#### **Role and Membership**

- The role of the MC is to satisfy itself as to the effectiveness and quality of the implementation of the Operational Programmes in line with Regulation (EU) No 1303/2013.
- In establishing the role and responsibilities of the Monitoring Committee, the principles of partnership set out in the Commission Delegated Regulation (EU) No 240/2014 were respected.
- The membership of the Monitoring Committee was established in line with Article 48 of Regulation (EU) No 1303/2013 and in line with Article 10 of Delegated Act (EU) No 240/2014.

## The Functions of the MC (1)

#### Examine and approve:

- The methodology and criteria used for selection of operations and any revision to the same criteria as proposed by the Managing Authority;
- The Evaluation Plan referred to in Article 114 (EU) 1303/2013 and any modification proposed by the Managing Authority;
- The **Communication Strategy** referred to in Article 116 (EU) 1303/2013 and any revision of this Strategy in accordance with the programming needs;
- Any proposal by the Managing Authority for any amendment to the Operational Programme/s;
- The Annual and Final Reports on implementation referred to in Article 50 (EU) 1303/2013;

# The Functions of the MC (2)

#### Examine

- any issues that affect the performance of the Operational Programmes referred to in Article 110 of Regulation (EU) No 1303/2013, including the conclusion of the performance reviews referred to in Article 49(2) of Regulation (EU) No 1303/2013;
- progress registered towards achieving the specific targets of the Operational Programmes, and the milestones defined in the performance framework referred to in Article 21(1) of Regulation (EU) No 1303/2013;
- the implementation of the Communication Strategy; Evaluation Strategy; Major projects; and actions to promote equality, equal opportunities and non-discrimination;

## The Functions of the MC (3)

Examine the implementation of the:

- actions to promote sustainable development;
- progress on actions to fulfil the applicable ex-ante conditionalities not fulfilled at the date of the submission of the Partnership Agreement and the Operational Programme/s;
- Financial Instruments under the OPs;
- SME Initiative Operational Programme (where applicable);

# The Functions of the MC (4)

- Act as the Committee responsible to examine and approve the annual and final implementation report for the 2007-2013 Operational Programme and
- May make observations to the Managing Authority in line with Article 49
   (4) of (EU) No 1303/2013.
