



Qualitative analysis: P.A. 1

Measure 1.1

Public aid for permanent cessation of fishing activities

- Since 2010 a total of four such schemes were launched with the last one dated November 2013. The main target of such measure was a capacity reduction within Malta's ageing registered fishing fleet. 25 beneficiaries received E.F.F. financing, 20 of whom had Blue Fin Tuna licences amongst others.
- Collectively, licences diminished by 1.7% and the fishing vessel register witnessed a diminution of 4757.13kW and 635GT. Along 2014 the Intermediate Body [I.B.] carried out checks on document retention by beneficiaries of the fourth scheme and facilitated the assessment of onboard cultural heritage in collaboration with Heritage Malta.

Measure 1.3

Investments on board fishing vessels and selectivity

- Safety onboard and improved energy efficiency were two pillars of the moderisation scheme launched way back in March 2010. 33 Grant Agreements had been concluded by the I.B. [the entity in charge of aid schemes].
- A second scheme was launched on 14 September 2013 with only one application being submitted in spite of wide publicity. Declared as ineligible by the Project Selection Committee.
- ➤ No calls were issued in 2014 but additional M.A. checks produced €2,766.10 of adjustments processed by means of the E.F.F. database.

Measure 1.4

Socio-economic compensation for the management of the Community fishing fleet

- A complement of 827 fishers were provided with training focusing on health and safety at sea between December 2010 and March 2011.
- ➤ €111,853.64 were certified to the Commission under this measure in 2013 adding up to a total of €224,401.04 and a corresponding E.F.F. share of €168,300.78.
- In 2012 the M.A. and the I.B. held meetings with regards to a second training course tackling navigation skills. No applications were submitted in respect of a call launched on 28 June 2013.

Measure 2.1

Productive investments in aquaculture

- ➤ A Grant Agreement was agreed upon under this specific measure in May 2013 for the value of €686,295.96.
- Project comprised the procurement of new equipment by the beneficiary including cages and chains for cultivating three species namely the sea bass, sea bream and also the meagre [gurbell], a local novelty in this sector.
- I.B. officers duly conducted On-the-Spot checks so as to verify the delivery of pertinent material prior to the end of December 2013.
- > A total of €209,241.83 was processed in 2014.

Measure 2.3

Investments in processing and marketing

- A call under this measure had been issued in September 2010. Two Grant Agreements were agreed upon in 2010 albeit one beneficiary dropped out in January 2014, with the M.A. recovering all allocated and paid funds.
- Upon completion, the remaining project brought to light a new aquaculture land base equipped with a modern fish processing plant and hygienic storage areas contributing to the employment of various personnel.
- ➤ 18 On-the-Spot checks were conducted by both the I.B. and M.A. in 2014 hence providing the necessary comfort for the payment of €81,581.11.

Measure 3.1

Fishing ports, landing sites and shelters

- Grant Agreement for the construction/relocation of a new wholesale fish market at Albert Town I/o Marsa has been signed on 21 November 2012 for a co-financing figure of €2,935,877.00. Two extensions were issued in 2014 due to delays in the granting of permission for the building of an electricity sub-station. Certified E.F.F. contribution for last year reached €499,387.16.
- ➤ Improving landing facilities at designed ports: two Grant Agreements were signed in 2014 involving M'Xlokk and M'Forn [Gozo] respectively. Necessary upgrading is well underway, expected to be completed by June 2015. The eligible amount both projects stands at €1,064,240.20.

Qualitative analysis: P.A. 3 [cont./ii]

- A third project involving multiple landing sites, particularly one at Marsa to accommodate those catches destined to be auctioned at the new fish market, is currently at Grant Agreement conclusion stage. This delay was caused by a land title obstacle which has now been settled. Other sites benefiting from this €749,567.14 investment include the Veċċja at St. Paul's Bay, in addition to smaller works on slipways at M'Scala and Xemxija.
- ➢ Mġarr [Gozo] is the fourth landing site which is presently being modernised. €14,250.36 have been processed by end of December 2014. Current progress status stands at conclusive embellishment works.

Measure 3.2

Development of new markets/promotional campaigns

- An open call was launched by the M.A. on 08 November 2012. Its fundamental importance lies with promulgating awareness about the advantages of regularly consuming fresh fish especially non-mainstream species. Outreach to encompass different media types and age groups.
- ➤ A conditionality letter was signed on 06 March 2013 and two tenders were awarded by end of October 2014. The ensuing Grant Agreement endorses a public eligible sum of €482,396.94.
- No payments were effected in 2014. Project completion set at July 2015.

Intermediate Bodies network

- Formal I.B. forum discussing implementation issues and common solutions to different problems established back in 2010 by the M.A. for Structural Funds.
- Offers the entities implementing several aid schemes the opportunity to exchange experiences whilst ameliorating coordination and secure consistency during the measure implementation process.
- The M.A. attended two meetings on 26 February and 06 October 2014 respectively. Themes like the demarcation between separate programmes, On-the-Spot checks and generic audit findings were discussed.

Monitoring arrangements [cont./iii]

Audit reports

- Following four audit on operations reports and also three system audit reports addressing various E.F.F. entities in 2013 such as the C.A., I.B. and M.A., the Audit Authority received timely follow-up replies coordinated by the M.A. throughout 2014.
- Following three audits on operations spanning P.A.s 1 to 3, the Audit Authority indeed ascertained that the existing management and control systems employed by the M.A. are effective with only minor improvements needed. No systemic problems were identified in the Annual Control Report 2014.
- An unqualified audit opinion was therefore referred to the Commission.

Problems encountered

Staff complement

Capacity kept proving to be a challenge for both the I.B. and M.A. Since both experience a reduction of personnel who left for other governmental jobs. Nevertheless, both entities managed to reach the commitment targets.

Technical expertise

- Internal expertise within other governmental departments was sought in respect of specific duties. A field recorder and a senior fisheries protection officer handled technical queries made by fishers at a publicity event.
- A private marine engineer was engaged for the purpose of conducting diving checks on aquaculture investments at St. Paul's Bay, measure 2.1.

Information and publicity

Promotional activities

Information stands were manned by the M.A. during two promotional activities highlighting E.F.F. achievements:

[i] Festa Ħut at Żurrieq on 01 June 2014;

[ii] Notte Bianca at Valletta on 04 October 2014.

Printed material

- Generic leaflets listing Fund structure were distributed in fisheries-themed jacket folders on both occasions.
- A children's education booklet was commissioned by the M.A. [contributing to much of its design], highlighting the importance of sustainable fishing.

Complementarity and O.P. changes

Double funding exercise

The M.A. has attended the Inter-Ministerial Co-ordination Committee meetings in prevention of double funding risk on 26 February and 06 October 2014. Checks executed before the meetings identified no such cases.

Budget shifts

- The fisheries O.P. underwent alterations as approved by a sixth written procedure on 11 February 2014. The fifth version of the O.P. hosted budget shifts from P.A.s 1 and 2 to P.A. 3 thus tapping unutilised funds.
- > Monitoring Committee approval was requested.








P.A. 1: disbursement 2010-2014




P.A. 2: disbursement 2010-2014




P.A. 3: disbursement 2010-2014




