2. OVERVIEW OF THE IMPLEMENTATION OF THE OPERATIONAL PROGRAMME (ARTICLE 50(2) OF REGULATION (EU) NO 1303/2013)

Key information on the implementation of the Operational Programme for the year concerned, including on financial instruments, with relation to the financial and indicator data.

The Managing Authority (MA) is presenting the sixth Annual Implementation Report (AIR) for the European Maritime and Fisheries Fund (EMFF) Operational Programme (OP) in Malta covering the seventh year of implementation. Its format is set on the model presented in Article 2 of Reg. (EU) No. 1362/2014 and on the FAME Support Unit CT04 Working Paper EMFF AIR (April 2018) guiding Member States in their formulation of Annual Implementation Reports. Its main objective is to provide EMFF key stakeholders with information on the implementation of the OP during year 2020.

In year 2020, the MA continued to focus on the constant monitoring of operations awarded in previous years, especially because 2020 saw the onset of the COVID-19 pandemic which affected various activities linked to several EMFF operations and the fisheries sector in general. The pandemic affected the implementation of the programme since Beneficiaries experienced late delivery of supplies, particularly those which relied on foreign production, and the postponement of physical/personal contact components such as seminars. Prospective applicants also found it difficult to submit all the requested documentation within deadlines as regards to launched calls. By end 2020, a total of 35 operations had been selected for EU co-financing. Three calls were issued: two open calls under Union Priority 2 (UP2) and one restricted call under Union Priority 3 (UP3).

The two open calls issued under UP2 were based on Article 47 of Reg (EU) No 508/2014 − *Innovation* (total public eligible amount: €800,000) The open calls were promoted through adverts published on the Malta Government Gazette, on all local Sunday printed newspapers and on the MA's websites. MA officials were available to assist prospective applicants with queries through phone calls, email exchanges and meetings. One application was submitted under the first open call for project proposals, issued in February and closed in April 2020, yet this was found non-admissible. Due to this, a second open call for project proposals was issued by the MA in June 2020 and two applications were submitted by the closing date. Whilst both project proposals were found eligible by the Project Selection Committee (PSC) and both complied with the objectives of the fund and the admissibility and selection criteria established for the call, only one application could be funded due to limited funds available under the specific Measure as well as the limited time-frame available.

The call issued under UP3, this being a restricted call, invited the Department of Fisheries and Aquaculture (DFA) to submit a project proposal based on Article 76 − Control and enforcement (total public eligible amount: €2,000,000). This was issued in March 2020 and closed in May, following an extension request submitted by the DFA due to circumstances related to the COVID-19 pandemic. However, as a result in a change in political direction, the application submitted was immediately withdrawn by the applicant.

The Annual Review Meeting between the MA and EC representatives was held on 12 November 2020. A week later, the EMFF MA held the sixth meeting of the Monitoring Committee (MC). This was planned for May, yet due to the COVID-19 pandemic it was postponed to 20 November 2020. The MC was held virtually and an update on the implementation of the OP was provided to all MC members. The Annual Implementation Report for year 2019 was already adopted by the MC via written procedure in May 2020.

In December 2020, the MA proposed an amendment to the OP, in relation to the introduction of a COVID-19 Temporary Cessation for fishing activities in line with Article 33 (1)(d) of Reg (EU) No 508/2014. This was proposed to the MC members via written procedure and then to the EC. It must be noted that this amendment was considered as incomplete by the EC in January 2021. In this regard, the MA withdrew its submission, yet informed the EC that it intends to re-submit a COVID-19 related measure in due course.

The MA's online webpage was regularly updated in order to meet CPR/EMFF Regulatory requirements, such as the list of selected operation as per Article 119 of Reg (EU) No. 508/2014. The MA ensured that the webpage included regulations, publications, reports, EMFF supporting documentation and other documents pertaining to EMFF upcoming calls.

2 Statement of Expenditures by Fund were submitted in 2020, both completed for accounting year ending 30 June 2021. One claim for payment, which amounted to $\[\in \]$ 734,210.86 (EMFF share) was submitted to the EC on 29 October 2020. The other claim for payment was submitted on 23 December 2020 and amounted to $\[\in \]$ 2,111,730.12 (EMFF share).

Under UP1, out of twelve operations, seven operations were completed, whilst five operations were under implementation by end 2020. The total public eligible amount paid by the end of the year stood at €9,137,129.88, marking a 27.46% increase from the previous year (2019). Out of this, a total amount of €8,528,798.95 has been verified by the MA and effectively certified. Under UP2, two operations were under implementation, one operation was officially withdrawn, whilst one operation was awarded. The total public eligible amount paid by end 2020 stood at €1,590,202.59. marking a 10.37% increase from the previous year (2019). Out of this, a total amount of €50,708.07 has been verified by the MA and effectively certified. By the end of the same year, the total public eligible amount paid under UP3 was €5,060,852.80, with various operations still under implementation. marking a 14.05% increase from the previous year (2019). Out of this, a total amount of €3,098,612.13 has been verified by the MA and effectively certified. The only operation which falls under UP5 was completed in 2018 with a total public eligible amount of €249,957.71 in payments. Out of this, a total amount of €248,501.29 has been verified by the MA and effectively certified. By end 2020, the total public eligible amount paid under UP6 stood at €1,600,000, with one operation in advanced stages, marking 56.77% increase from the previous year (2019). €1,100,450.91 worth of payments related to Technical Assistance was processed by end 2020, marking 42,73% increase from the previous year (2019). Out of this, a total amount of €1,081,375.83 has been verified by the MA and effectively certified.

3. IMPLEMENTATION OF THE UNION PRIORITIES

3.1. Overview of the implementation (Article 50(2) of Regulation (EU) No 1303/2013)

The MA monitored ongoing operations, ensured effective implementation, conducted management verifications and kept regular contact with the Beneficiaries.			
	Ongoing operations:			
	EMFF 1.23.3: Construction of a breakwater at Qrejten point in the port of Marsaxlokk. An extension to the GA's validity until April 2021 was requested (and approved) on account of work delays brought about by inclement weather conditions during the winter season. By end 2020, the physical aspect of the project had reached an advanced stage, 6000 tonnes of reinforced concrete and additional local hardstone were in place whilst utility and safety equipment was being installed.			
	EMFF 1.23.5: Upgrading of the fisheries infrastructure of Gozo. An extension to the GA's validity until June 2021 was requested by MGOZ on account of procurement delays in relation to the purchasing of five amphibious boat trailers and a towing vehicle for use in the designated port of Mgarr. This important area is the host of another project component, focusing on the installation of utility services in full complementarity with another EMFF project (see EMFF 1.23.6). Meanwhile, infrastructural works at the smaller designated port of Xlendi were completed and inaugurated in June. The area is now more organised and safer for the respective operators conducting landings and routine maintenance.			
	EMFF 1.23.6: Upgrading of Mgarr Gozo and Marsaxlokk Malta fishing ports. An extension to the GA's validity until April 2021 was requested (and approved) on account of work delays brought about by inclement weather conditions during the winter season. By end 2020 the physical aspect of the project had reached an advanced stage, concrete and dredging works were being finalised so as to enable the installation of new pontoons.			
	EMFF 1.9.1: Compensation Scheme for the Temporary Cessation of fishing activities. The first sheme was launched in 2019, whilst the second scheme was launched in November 2020. 43 applications

were submitted, out of which 28 were accepted. As in 2019, the Selection Committee at DFA scrutinized the application forms in terms of the information and declarations submitted in order to determine eligibility and selection of the applicants. 15 applications were declared ineligible due to not having met the minimum Swordfish landings (SWO), others went out fishing in December (this being the month for temporary cessation), whilst another withdrew his application. An applicant fisher was also identified as having an infringement (being not compliant with CFP rules and currently has points assigned in the national register following Court judgement) and hence was not eligible to benefit from the scheme.

EMFF 1.4.1: *Training for fishers.* The DFA requested an extension until March 2021. This operation was affected by the pandemic. In line with directives issued by the Maltese Health Authorities, the contractor suspended the delivery of the remaining training sessions. The MA was informed that the sessions could not be conducted remotely since they required the use of specialized equipment. The certificate-giving ceremony was also cancelled. Over 400 participants benefitted from this project.

Completed operations:

EMFF 1.16.1: A scientific study to improve trawl gear selectivity. This was completed in 2019.

Operations EMFF 1.20.1, EMFF 1.20.2 and EMFF 1.20.3 were concluded in 2018. In 2020, a closure report was prepared by the Beneficiaries in view of the RI referring to a change in net profits. This involved verification by the MA that the RI was reached, basing on the difference between the financial figures declared in 2019 and the ones declared in 2020 by the Beneficiaries' private accountant. All operations reached the RI identified in the GA. The below numbers confirm the positive business impact left by Union co-financing.

- EMFF 1.20.1 The GA target for completion for operation was set at €700 whilst Net profits for 2019 were €4,933.44
- EMFF 1.20.2 The GA target for completion for operation was set at €850 whilst Net profits for 2019 were €1,098
- **EMFF 1.20.3** The GA target for completion of operation was set at €6,800 whilst Net profits for 2019 were €12,666

Operation **EMFF 1.20.4** was concluded in 2020. In 2021, the MA shall conduct a physical OTS on board the vessel to ascertain that all line items were purchased, installed and operational. A closure

report is to be prepared in 2022, following registration of 2021 financials.

EMFF 1.23.1: The Construction and Finishing of an Office on the Fish Landing Site in the Marsaxlokk Designated Port.

The pandemic had a negative impact on the construction and finishing process of the landing office. Foreign workers returned home and substitute workers had to be sought. The contractor and his suppliers experienced difficulties and delays in sourcing the required supplies from abroad. In fact, the contract was extended and the Landing Office was inaugurated in September. The target for RI 1.8 was set at 1116 FTE at GA stage. The Beneficiary can confirm whether this has been achieved in 2022, as data is published on an N+2 basis. It also stated that the RI is unlikely to be achieved due to a decrease of 522 FTEs between 2014 and 2020. By procuring a moveable crane, landing operations in the area became safer and more efficient. The office enables DFA officials to perform their duties in an enclosed, weather protected environment resulting in a more effective service, hence raising the overall standards of the port. Local fishers will be provided with a better service and overall work experience. Through the completion of the project and the placement of a permanent staff member in the office, the DFA was able to achieve a national Simplification Measure SM.35/2020 entitled 'Isir konsolidament tas-servizzi offruti filqasam tas-Sajd. Is-servizzi kollha lill-klijent ser jibdew jinghataw minn post wiehed. Ghal dan il-ghan ser jinfethu żewż ufficini wiehed fit-Tramuntana u l-ieħor fin-Nofsinhar ta' Malta. B'hekk jiġi evitat kull skariġġ għas-sajjeda'. This enabled the DFA to extend the provision of its services into the community.

EMFF 1.23.2: Refurbishment and upgrading of slipways in the port of Marsaxlokk. Completed in 2019, the project provided necessary refurbished and upgraded infrastructure to improve access to the port. The slipways provide better access to all fishers where vessels can be moved to and from the sea without any difficulties, thus better working conditions. RI 1.8 was set at 783 FTE at GA stage. The Beneficiary reported 689 FTE since it is early to recognize the benefits that indirectly the project would have on the FTE in the fisheries sector and the effects of the pandemic are yet to be determined.

By end 2020, a total amount of \in 9,137,129.88 in public eligible funds were paid under this UP, out of the total allocation of \in 11,577,239 stipulated in the OP, marking a 27.46% increase from the previous year (2019).

2 - Fostering environmentally sustainable, resource efficient, innovative, competitive and knowledge based aquaculture

Calls launched in 2020 and Evaluation of Project Applications

In year 2020 two open calls for project proposals were issued under Article 47 – *Innovation* of Regulation (EU) No. 508/2014. Under the first open call, one application was submitted by *AquaBioTech Ltd*. The proposal was found non-admissible by the PSC, since the applicant failed to submit the required documentation by the stipulated deadline. As a result, another open call was issued under the same measure in June 2020, with a budget of €800,000. Two project proposals were received, one by *AquaBioTech Ltd* and another by the Department of Fisheries and Aquaculture. Whilst both project proposals were found eligible by the PSC, and both complied with the objectives of the fund and the admissibility and selection criteria established for the call, only one application could be funded due to limited funds available under the Measure. In this regard, the Managing Authority issued a grant award letter to *AquaBioTech Ltd*. since it ranked first out of the two.

Ongoing operations:

EMFF 2.1.1: Development of new, innovative aquaculture technologies and facilitate knowledge transfer in AquaBioTech Group, Beneficiary: AquaBioTech Group. The main goal of the project is to create a physical space from where the beneficiary organisation would be able to implement research and innovation activities through a structured cooperation platform involving students from Malta's higher education system, as the next generation of aquaculture experts. This Centre will host a state-ofthe-art training facility and conference room, various laboratories as well as offices to carry out fish health diagnostics and aquaculture services presently absent on the island. The proposed infrastructure will enable the beneficiary to develop new vaccine and feed testing methods which will be used in the recently developed Recirculation Aquaculture Systems (RAS) facility of the Company. New vaccines and feeds will reduce the impact on the environment, reducing dependence on fish meal and oil, whilst fostering a more sustainable use of resources in aquaculture.

EMFF 2.2.1: Productive Aquaculture Investments at Pisciculture Marine de Malte Limited, Beneficiary: Pisciculture Marine de Malte Ltd. An extension to the Grant Agreement's validity until 30 June 2021 was agreed upon in order to cater for the last two line items within the project, namely the tailor-made manufacturing and installation of cabins on existing aquaculture work boats and the procurement of a new work boat. The latter was inserted in the project as a new component upon a justified request which emphasised the dynamic clientele-based necessities of the concerned

	aquaculture firm especially in terms of productivity and safety measures. The introduction of a new component in the operation led to a fourfold increase in contracting. MA approval was provided upon the comfort that Article 24 of the Grant Agreement concerning change in scope, was not breached. The new work boat was built in a Greek shipyard and arrived in Malta during quarter 4 of 2020. Although five reimbursement claims were processed, covering a substantial portion of the overall project grant, not all the transactions listed in the new work boat contract were settled by end of year. Documentary checks by the MA confirmed the lawfulness of all claims.				
	EMFF 2.3.1: <i>Productive Investments in non-food aquaculture using RAS in AquaBioTech Group</i> , Beneficiary: <i>AquaBioTech Group</i> . The difficult Covid-19 situation in Malta, featuring a partial lock-down and several precautionary measures such as remote working encouraged by Government, affected the progress of management verifications on this project. Physical On-The-Spot checks could not be easily executed given the biologically sensitive nature of the research centre. Diligent preparation for claiming the reimbursement of staff costs not falling under the Simplified Cost Option mechanisms, was undertaken by the Beneficiary. From its part, the MA agreed to extend the Grant Agreement validity until 30 June 2021 owing to the encountered <i>force majeure</i> .				
	EMFF 2.3.2: Increasing productivity, efficiency and sustainability of Blue-fin tuna fish farming operations, Beneficiary: Malta Fish Farming Ltd. In line with previous years' reporting, the Managing Authority suspended payments in accordance with Article 132 [2] [b] of the Common Provisions Regulations referring to projects' suspension in case of an ongoing investigation. In fact, the MA, through official correspondence sent from the office of the State Advocate, terminated the project accordingly.				
	Notwithstanding the complete removal of the MFF Ltd operation, the target output indicator for the entire UP2 is still being achieved.				
	By end 2020, a total amount of €1,590,202.59 in public eligible funds were paid under this UP, out of the total allocation of €3,092,781 stipulated in the EMFF OP, marking a 10.37% increase from the previous year (2019).

competent body under UP3, was invited to submit a project proposal with a maximum total public eligible amount of €2,000,000. The MA issued the call in March 2020. The DFA submitted an application by the closing date of the call, being 8th May, due to an extension provided because of COVID-19. However, the project proposal was immediately withdrawn by the applicant. Since the application form was withdrawn, its evaluation by the PSC did not proceed.

The project proposal which was submitted by the DFA in 2018 entitled 'The supply, delivery, installation and commissioning of a CCTV Network System around Malta and Gozo including a control centre for the Department of Fisheries and Aquaculture', submitted under Article 76, was also withdrawn by the applicant. This was because the legislative framework required to install such system around the island that could not to be finalised by the end of 2020 due to issues revolving on data protection. Consequently, the competent body on control is undergoing internal consultations to see what alternative actions are feasible. The applicant informed the PSC and the MA that there is still a need for such project and therefore the DFA will continue with the finalisation of the legislative framework, hoping that such project proposal can be implemented during the next programming period. In this regard, the PSC accepted the withdrawal of the application and halted its evaluation process.

Ongoing Operations:

During 2020, the implementation of **EMFF 6.2.2**: *Data Collection Multi-Annual Programme 2017-2019*, which falls under Article 77 – *Data Collection*, was at advanced stages of implementation. An extension to the operation until July 2021 was requested by the Beneficiary due to the re-issuance of a new tender (since no bids were received at the first time) and due to extension requests submitted by suppliers as a result of COVID-19. Such extension request was approved by the MA. Throughout 2020, management verifications were conducted and financial corrections, as well as recommendations, were made accordingly.

EMFF 6.2.3: *Data Collection Multi-Annual Programme 2020-2021*. By the end of Quarter 1 of 2020, the PSC completed the evaluation of the data collection operation for years 2020-2021, which entails a continuation of the previous data collection multiannual programme. The MA issued a grant award letter and implementation initiated by the Beneficiary. The GA was signed in September 2020 and implementation was initiated, with 25 claims inputted in the EMFF Database system.

4.2. Issues which affect the performance of the programme and the corrective measures taken (Article 50(2) of Regulation (EU) No 1303/2013)

During this reporting period, all stakeholders faced the difficult unprecedented challenge brought about by the Covid-19 pandemic, as already explained in Section 3.1 above. This was a *force majeure* situation which affected the programme in two ways, namely: (i) the slowed-down implementation of some projects due to late delivery of supplies, particularly those which relied on foreign production; the postponement of physical/personal contact components such as seminars etc., together with (ii) prospective applicants' diminished ability to submit all the requested documentation on time with regards to new calls. The Managing Authority was duly made aware of cases involving difficulties in the provision of quotations from foreign suppliers operating on a reduced working schedule.

Although there was no template solution to the problem, mitigation measures were successfully embarked upon to achieve the programme's targets for year 2020 just the same. Considerable effort was made by the Managing Authority to coordinate work remotely yet effectively, between its own hierarchy and with third parties. Meetings were held digitally as far as technically possible, whilst certain management verifications at the Beneficiary's site (i) were held during periods of more lenient Covid-19 restrictions, enabling cautious inter-personal contact with Project Leaders etc. or (ii) were based on material transferred electronically especially via extra uploads to the EMFF 2014-2020 payments database. Furthermore, the annual Monitoring Committee meeting was held late in the year, as opposed to its usual timing, with the Managing Authority opting to wait for the stabilisation of restrictive measures in between virus waves. The digital platform used for the said meeting fulfilled all the needs for an active discussion. Another positive result along the same terms was registered in respect of the annual publicity activity obligation. As reported earlier investments from the Fund were this time not promoted on a single-day event or by means of traditional media sources such as radio and television; they were instead innovatively publicised on fourteen buses with different routes, using the services of the country's sole public transport operator and its advertising partner.

The efficacy of the above-mentioned mitigation measures is most importantly reflected in Malta's ability to keep a steady certified disbursement flow in fulfilment of the decommitment threshold for 2020. Since repeated difficulties were being encountered with restricted calls issued to national entities apropos Article 47 Innovation (aquaculture), mainly revolving around the proposals for independent validation of results, the Managing Authority decided to resort to an open call dated February 2020. Feedback was hindered by the Covid-19 limitations affecting local enterprises and therefore a second open call was launched in June 2020. Two eligible submissions were received emanating from a government department and a business enterprise. Both organisations could not immediately implement their pioneering innovation ideas on their own financial steam.

Concerning the second call for temporary cessation applications, invitations with Application Forms as an attachment were sent by postal mail to respective fishers on the full-time and part-time registers of the Department of Fisheries and Aquaculture (the competent public entity), rather than proposing a personal pick-up of documentation by prospective beneficiaries from the Department's premises. Uptake was once again satisfactory, featuring amounts like those of the first call dated 2019.

On another note, severe weather conditions during the winter months of 2019-2020, forced contractors to pause concrete works of a large magnitude (like bedrock levelling and foundation-laying) for the sake of safety. Consequently, as per the formal paperwork between the Managing Authority and beneficiaries covering specific projects' implementation extension, efforts were undertaken in summer 2020 to recuperate some of the lost time. The contractors working on the construction of a breakwater at Qrejten point in the port of Marsaxlokk (project coded EMFF 1.23.3) as well as the upgrading of the Mgarr (Gozo) and Marsaxlokk (Malta) fishing ports (project coded EMFF 1.23.6), are experienced in marine

works apart from being very well-equipped. Diligent procurement carried out by Infrastructure Malta (beneficiary) as confirmed by the Managing Authority's verifications and by the Audit Authority's audits on operations, yielded a selection of contractors who could respond to unforeseen circumstances in an organised manner. The procurement of third-party project management services additionally provided individual focus on day-to-day activities, to the comfort of stakeholders (such as the Managing Authority) engaged in regular checks.

Vis-à-vis the targets and indicators to be reached by 2023 (N+3), few are the risks being anticipated by the Managing Authority. In fact, the latter intends to channel savings under Union Priority 1 to an operation within the same Union Priority which has already been audited by the Maltese Audit Authority and who produced a clean report in view of the procurement processes adopted. Such a modus operandi will hopefully enable an earlier programme closure, meaning an earlier tapping into the 2021-2027 programming period.

Risks of double-financing through different Union funds used to be tackled within the ambit of the Inter-Ministerial Coordination Committee. In view of the Covid-19 restrictions, alternative arrangements were put in place to ensure the same usefulness. In fact, the Funds and Programmes Division is in constant discussion with the ESF and the ERDF MA's on projects which are complementary. Furthermore, the FPD is also a member of the Monitoring Committee of both funds.

5. Information on serious infringements and remedy actions (Article 114(2) of Regulation (EU) No 508/2014

Information and actions taken on cases of serious infringements as referred to in Article 10(1) and non-respect of durability conditions and remedy actions as set out in Article 10(2).

No serious infringements were encountered neither by the Managing Authority during its verifications nor by the Audit Authority during its audits on operations in quarter 4 of 2020. Minor administrative inquiries and observations for improvement were mostly tackled in earnest by Project Leaders to the advantage of documentary trails. Pending follow-up checks were conducted as necessary.

The successful applicant under Article 47 Innovation (second call June 2020) had no infringements on the records of the comptetent governmental entity, as indicated in project selection paperwork.

Risk-averse decisions have been (and will continue to be) taken by the Managing Authority in connection with (i) terminated project EMFF 2.3.2 – Tarantello case still under a magisterial inquiry, and (ii) Control operations scrutinised by the European Commission. The aim remains to place funds were implementation is fiscally clean, more so given the consideration that Union funds incorporate contributions from 27 Member-States and not just the Maltese taxpayer. In this regard the EMFF is also regularly informed of any progress which Malta achieves in having this suspension lifted, and has also pledged its support and assistance to the competent authorities to resolve this issue at the earliest. The aim of the EMFF is to ensure 100% absorption until the end of 2023.

With regards to the second call for applications issued in quarter 4 of 2020 by the Department of Fisheries and Aquaculture on behalf of the Managing Authority under Article 33 Temporary Cessation, the protocol used in 2019 for the first call was re-applied. This system of dual checks (already described in the Annual Implementation Report 2019), detected no serious infringements under Article 10(1) of Regulation (EU) No. 508/2014. The infringements mentioned under UP1 (temproary cessaction scheme) refers to shortfalls identified at eligibility stage of the applicant and hence does not fall under the spirit of Aritlce 10 (1) of Regulation N. 508/2014. As one might presume, the experience garnered through the first call definately contributed to enhanced planning and execution of checks this time round.

Article 41(8) states that applications made by operators from the small-scale coastal fishing sector shall be treated as a priority up to 60% of the total support allocated for the replacement or modernisation of main or ancillary engines referred to in paragraph 2, over the entire 2014-2020 programming period. This was addressed in past calls under Union Priority 1, Specific Objective 5, Article 41.2. A clause was included in the Guidance Notes to applicants where it was indicated that 'In line with Article 41.2 of Regulation (EU) No. 508/2014, support shall be granted to vessels up to 12 meters in overall length, provided that the new or modernised engine does not have more power in KW that the current engine.' However, no engine-related calls were issued in 2020. None are currently envisaged, but should further calls be issued in 2021, the same approach will be followed.
