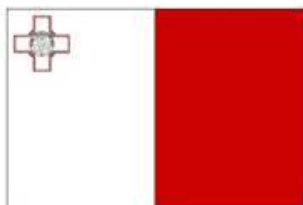

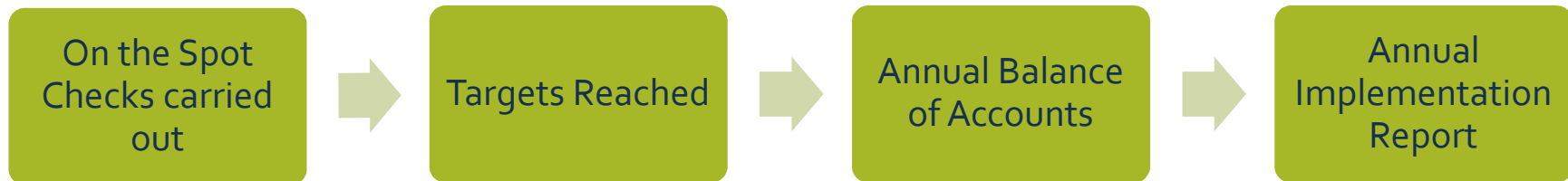

Designation of the Responsible Authority

- Following the opinion issued by the IAID, the RA was officially designated on the 7th of December 2015 and communication was submitted on the same day to the European Commission.
- By means of communication dated, 15th April 2016, the Commission requested information on the Management and Control System from the Responsible Authority, the Designating Authority and the Audit Authority. Feedback was submitted on 17th May 2016.
- Following this information Commission informed the RA on the 16th of September 2016 that no major issues were found to be present on the management and control systems set up.

Modification of the NP

On the 8th February 2017, the Commission has communicated that additional funds will be made available to the Member States to address the most pressing needs and requirements of the sector of each Member States.

AMIF

- 1,000,005 under Integration
- 861, 000 under Return

By end of May the national programmes were sent to the Commission, following a written procedure for approval of the Monitoring Committee Members. This were subsequently approved in August (AMIF).

Annual Implementation Report

- Following circulation of the draft Annual Implementation Report, the Report was submitted to the European Commission on the 27th March 2018 and was subsequently accepted by the Commission on the 14th June 2018
- The results as shown in this presentation will be reproduced in the Annual Implementation Report and circulated for the Committee's review.

Interim Evaluation

- Following the RA's participation in all the Evaluation Network meetings organised by the European Commission, and the adoption of the Delegated Act, the RA embarked on the procurement of Independent Evaluators in order to fulfil the requirement set out in Article 57 of the Regulation 514/2014.
- MOU between the FPD and the SID was signed on the 30th March 2017
- Report concluded in December, written procedure issued on the 14th of December and closed on the 27th December.
- The report was the submitted on the 28th December and so far no feedback has been received.

Mid-Term Review

- In line with Article 15 of Regulation 514/2014 of the 16th April 2014, the European Commission and each Member State carried out a review on the current situation of implementation on the national programmes and in the light of development in Union policies and interim evaluation reports.
- Malta carried out this review in conjunction with the relative stakeholders of the sector and proposed a number of actions to the European Commission for eventual inclusion in the NP.
- This resulted in a forthcoming update of the NP in order to include the actions agreed upon with the European Commission and taking into account the current needs of the local context.

Proposed updates to the NP

- The written procedure of the AMIF programme will include a variety of changes, including budget shifts, the introduction of a project in relation to victims of human trafficking as well as general editorial changes which are necessary in order to specify further the type of initiatives which the NP is financing.
- Additional allocations under the Return and Integration specific objectives will also be included.
- The deadline to submit the revised NP is the 23rd of July and therefore a written procedure underlining the changes will be launched in the coming weeks.

- Press Releases have been issued whenever a project has been approved. In addition, as part of the annual event of 2016, a general press release covering the achievement of the Funds was published.
- The 2017 Annual Event took place as planned. Two 4-minute promotional video clips were produced, one on AMIF and one on ISF and were launched on the RA website.
- A promotion campaign has also been implemented. A leaderboard advert has been placed on the Times of Malta. This has been done to promote ISF and AMIF with a link to the RA website. This campaign ran for a total of 7 weeks and was then also connected with a link to the promotional video clip.

These stands were manned by RA officers who distributed leaflets and promotional items to the general public.



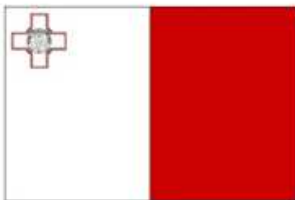


- The Migration and Security Information System has been launched in June 2016.
