










% of Projects based on Number of Projects





Evaluation Activities Programme Level Evaluations

- Forthcoming Thematic Evaluations:
- The Terms of Reference for "Assessment of the contribution of OPII initiatives to education and lifelong learning" are currently being drafted

- Cohort Study:
- Terms of Reference were finalized and contract with NSO being finalised







Mid-Term Evaluation

- Objectives were to assess the relevance, efficiency and effectiveness of OPII.
- An Internal factors workshop was held on 14 January 2011.
- Final Mid-Term Evaluation Report on OPII was submitted to the MA on 7 April 2011





Mid-Term Evaluation Outcomes (Brief Overview)

- Relevance:
 - the OP is still relevant in today's socio-economic context
 - there is a balance between policies and the activities being co-financed
- Efficiency:
 - evidence of 'ramping up' supporting the view that current process leading up to approval of projects does not present major indication of bottlenecks
- Effectiveness:
 - for most part, planned achievement percentages of output and result indicators show healthy prospects of likely achievement





Communication Plan Review

- Final Report on the Communication Plan (by the MTE) was submitted to the MA on 13 April 2011
- The MA has taken the findings of the MTE into consideration and is currently concluding the review
- The revision will provide for:
 - a better monitoring structure of information and publicity;
 - a strategy which is more focused on the promotion of tangible results; and
 - reduction in overlaps between the different stakeholders.





Training and Capacity Building

- At MA level: 12 January 2011
- 5 officers from the Financial Control Unit within the MA participated in inhouse training on the Assurance Model and Modification to Article 55 'Revenue Generating Projects'
- At Programme Level: 29 March 2011
- 13 officers from the MA participated in the seminar directed by the European Court of Auditors on 'Sound Financial Management of EU Funds'
- Other participants included the CA, AA, NAO, IBs, Beneficiaries and Ministries
- Several other training courses were attended overseas namely the New Member States Conference on Cohesion Policy attended by 2 officers from the MA and the 5th Cohesion Forum attended by 2 officers representing MCESD,1 officer from ETC and 1 from the Ministry for Gozo.






Concluding Remarks on Implementation in 2011

- Clearly the usual issues of procurement and payments continue to be a challenge for most Beneficiaries
- Despite efforts, payments on the Aid Schemes, particularly TAF, are still not flowing at the desired pace
- On the positive side these has been a 24% increase in contracting and 53% increase in payments in the last 5 months
- In terms of results, 37,524 persons were trained under the OP till the end of 2010
