employability and adaptability of the workforce is finalised and was submitted to DoC
for vetting and launching.

 regard. Simplification of the administration of both Aid Schemes is definitely
 a step in the right direction.

More information on the upcoming calls shall be provided by the Managing Authority in the coming weeks.






Concluding Remarks on Implementation in 2011
