





Structural Funds Database 2007 - 2013

- New modules released
 - Updated rejection of invoices mechanism

 - New reports related to certain expenditure which is reported in Annex III and Gozo expenditure
- Capacity building:
 - Two newly recruited staff at the end of 2011
- Tutorials, Guidance notes and FAQs have been updated
- SFD was brought in line with GM ICT policies
- Enhanced reporting and more accessible mechanisms across a number of functions addressing the needs of different entities and different reporting and monitoring obligation
- Application forms have been updated
- Six training sessions held in 2011

Information and Publicity (3)

- A new pre-announcement to Call 8 for Project Proposals was launched through adverts, press releases and website updates in December 2011
- The Local Informal Information and Publicity (LIIP) Network has been set up and a meeting was held in November 2011. The second LIIP meeting shall be held on 13th April 2012
- In 2012 PPCD will create a stand-alone website to showcase all projects (ERDF, ESF, CF) in a more friendly, visual and interactive manner, intended to remain 'live' until the end of the programme





Evaluation Activities Evaluations being carried out:

EC Level

- Gender mainstreaming in Training and Capacity Building (Belgian ESF Agency)
- Gender and Evaluation in the ESF (Gendercop)
- Effective management of EU Structural Funds (Ministry of Finance Republic of Lithuania)

Programme Level

Cohort Study:

- The inception Cohort Study was submitted by NSO on 27th December 2011.
- First data set of beneficiaries has cut-off date end of January 2012.

Thematic Evaluation:

 The tender dossier for the assessment of the contribution of OP II initiatives to education, lifelong learning and supported initiatives to the enhancement of employability and adaptability of the workforce was presented to the Evaluation Steering Group on 27th January 2012.







Training and Capacity Building

- Training on Document Retention and Basic Principles of Control Preparing for a Spot Check held on 4th and 7th November 2011, organised by the Financial Control Unit and attended by 18 OPII officers
- Follow the Logic Trail Training Session held on 9th November 2011, organised by the SFD Unit and attended by 7 OPII officers
- *PPR Template Training* held on 14th and 15th December 2011, organised by the MA in Gozo and in Malta respectively, and attended by 11 participants who work on OPII Projects
- Briefing Session in relation to OPII Call 8 held on 15th December 2011, organised by the MA with 47 participants in attendance
- PPR Template Question and Answer Session, held on 21st December 2011 by the MA, and attended by 3 participants who work on OPII Projects





Concluding Remarks on Implementation (1)

- The OPII Unit has been focused on the SoE that commenced in January 2012; a significant amount of checks were undertaken during the verification process, prior to certification of the payments.
- The simplification exercise with regards to the administration of the ESF Aid Schemes was concluded for both Schemes. A positive outcome is expected in 2012 as a result of this exercise.
- The 9th Call for new Project Proposals shall be launched in Q2 of 2012 for Priority Axis 3. More information on the upcoming call shall be provided by the Managing Authority in the coming weeks.
- The OPII Unit is currently also compiling the Annual Implementation Report for the year 2011







Concluding Remarks on Implementation (2)

- The main focus with respect to the year 2012 is ensuring the continued efficient disbursement, verification and certification of the Projects' expenditure
- Evaluating and awarding grants with respect to Calls 8 and 9 (to be launched shortly) and issuing any further calls as necessary
- Monitoring of Projects to ensure the successful implementation of the Projects as well as full absorption of funds in the 2007-2013 Programming period
- Continue dealing with the ongoing evaluations as well as organise further training sessions


