JASPERS

- Malta was the first Member State to sign the 5th Action Plan with the EIB for 2010.
- During 2010, 11 missions took place (& 2 teleconferences) mobilising a total of 15 JASPERS experts.

JEREMIE

- Q1 2010 Minister of Finance and EIF signed the Funding Agreement allocating €10 million to the Holding Fund.
- Q3 2010 Call for Expression of Interest for Financial Intermediaries was launched & 3 Applications were received.

OP towards the Lisbon Objectives



- €283,990,000 are earmarked for Lisbon Agenda related projects
- Current commitments (Community amount) sums up to €188,521,511 which is equivalent to 66% of the Programme's earmarked amount





Problems Encountered and Measures Taken



1. Project Selection Process

- Main Issues:
 - Lengthy process in terms of Project Selection
 - Fragmentation in terms of Projects Submitted leading to volume of work created compared to funds committed
 - Complex nature of projects submitted requiring multiple clarifications and additional data or studies
 - Availability of Committee Members
- Mitigation Measures:
 - Efforts to increase the number of scheduled meetings
 - Revisions in the PSC procedures





Problems Encountered and Measures Taken (cont.)



2. Public Procurement Process

- Main Issues:
 - Delays due to centralisation of Procurement process
 - A substantial amount of unsuccessful bids (17% of the procedures) leading to re-launching of tender
 - Limited amount of experts (both at Beneficiary and DoC level)
- Mitigation Measures:
 - DoC revised the contracting procedures allowing the possibility of an additional two working days for the bidders to rectify its administrative compliance position
 - DoC updated and simplified tender templates with a view to reduce administrative errors
 - Ongoing efforts towards increasing capacity





Problems Encountered and Measures Taken (cont.)



3. Planning and Environmental Permitting Process

- Main Issues:
 - Planning Permit automatically impacts the Procurement Process
 - Complexity of EIA and Traffic Impact Statement
 - Territorial Constraints
 - Contestation by various stakeholders
- Mitigation Measures:
 - Preparation of necessary studies at an early stage
 - Pro Active Approach in terms of Consultation Process with a view to pre-empt potential issues
 - Intensified co-operation between MEPA and various Government Departments and Authorities
 - Involvement of MEPA at High Level Monitoring Meetings with a view to closely monitor the situation





Problems Encountered and Measures Taken (cont.)



4. Priority Axis 4

- Main Issues:
 - Clarifications with respect to the Interpretation of Article 55 resulting in a number of Beneficiaries not being able to provide the relevant funding
 - Development of a Feed In Tariff Policy
- These issues gave rise to delays in the preparation and finalisation of Grant Agreements
- Mitigation Measures:
 - MA discussed with EC the interpretation of Art 55
 - MA closely followed the development of the Feed In Tariff Policy with MRA

- 12 contracts were signed in 2010
- The Malta South Sewage Treatment Infrastructure was in its final stages of completion with the Rinella pumping station at Rinella in Kalkara (Component 2), the Xghajra pumping station (Component 3) and the 1.7 km Transmission Gallery from Rinella to Ta' Barkat limits of Xghajra (Component 4) fully completed. The Urban Waste Water Treatment Plant (Component 1) was close to completion.

- All works tenders launched, one of which awarded in 2010









Rehabilitation and Restoration of Closed Landfills (PA 5):

- Approved by EC in July 2010
- In 2010 3 project service management tenders were launched for all 3 landfill sites (2 of which were awarded). 2 major works tender for the M'Scala and Maghtab site were also launched







Malta South Sewage Treatment Infrastructure (PA 5):

- Approved by EC in November 2010
- All contracts foreseen under this project were signed by end 2010 and the project is expected to be operational in 2011
- By end of 2010, the status of works was as follows:
 - 91% of works completed on the South Sewage Treatment Plant
 - 98% of works completed on the Rinella Sewage Pumping Station
 - 62% of works completed on the Submarine Outfall
 - Xghajra Pumping Station and Transmission Gallery were complete







National Flood Relief Project (PA 4):

- The MA continued with the implementation and monitoring of the Communication Plan
- Data on activities carried out was gathered in order to update the Plan in 2010

Annual Event

- The Annual Event for 2010 consisted of two information festivals (one in Malta and another in Gozo) held in September 2010. These included:
 - Information booths presenting selected projects under the chosen themes:
 - Employment Opportunities
 - Education and Health
 - Science and Technology
 - the Natural and Built Environment
 - PPCD Information booth
 - Children's Corner with drawing competition
- The Event was complemented by the distribution of an information/ promotional leaflet to all households in Malta and Gozo





Information and Publicity (cont.)



- Other information and publicity measures to promote OP I included:
 - Procurement of various promotional items
 - Participation of PPCD staff and the IBs on local radio and TV programmes
 - Networking with the INFORM network of DG REGIO
 - Launch of Calls for Project Proposals on local newspapers and press release by both the MA & the IBs
 - Organisation of various information sessions by MA & one-to-one marketing & info sessions by IBs
 - Assistance through Email Helpdesk
 - Enhanced web-presence through regular updating of the MA's website <u>www.ppcd.gov.mt</u>, a page on a social networking site and the respective IB websites.





Communications Plan Review

- May 2010 MC was notified that an internal review of Communication Plan was being carried out
 - Reasons which led to the review included:
 - the pace of project implementation
 - publicity at IB and Beneficiary level
 - overexposure and repetition of publicity actions
 - limiting print publications
 - use of in-house resources
 - A number of activities which were listed in the Plan have already been implemented
- The Mid-Term Evaluation also assessed the Communication Plan
- MC had been informed that MTE outcome would be taken into consideration in the review
- Since MTE has recently been concluded, the review of the Communication Plan shall be finalised during the coming weeks

As at 2010 there were:


- 65 mainstream projects and 9 Aid Schemes under implementation
- 42 Public Entities/NGOs/Local Councils were benefitting
- 448 Enterprises were benefitting from Aid Schemes and 1,856 households were benefitting through the domestic scheme
- Circa 70% of the Programme was committed
- €128,421,758.08 payments were made
- €96,638,429.12 of eligible public expenditure was certified to the EC
