## Introduction

The Measures and Support Division (MSD) has been designated by the Managing Authority (MA) as an Intermediate Body (IB) responsible for administering European Regional Development Fund (ERDF) Grant Schemes through the implementation of Support Measures under the 2014 – 2020 programming period.

The Start-up Investment Grant Scheme is an aid scheme under the Business Enhance ERDF Grant Schemes initiatives designed to address the needs identified in the Operational Programme I “*Fostering a competitive and sustainable economy to meet our challenges*” as approved by Commission Implementing Decision C (2014) 9966 Final dated 15 December 2014.

This scheme falls under Priority Axis 3 of Operational Programme I, more specifically:

- Investment Priority 3a - *‘Promoting entrepreneurship in particular by facilitating the economic exploitation of new ideas and fostering the creation of new firms, including through business incubators’*; and
- Specific Objective 1 - *‘Creation of employment opportunities through the provision of infrastructure, financial incentives as well as support services’*.

## Scope of Document

This document is aimed at assisting applicants in the compilation of the application form and its submission. Prospective applicants are expected to have read these Notes to Applicants together with the:

- Guidance Notes for the Start-up Investment Grant Scheme; and
- Guidelines for Implementation issued by the IB.

## Call for Applications

The Start-up Investment Grant Scheme shall be administered through an open rolling call. The IB shall issue public calls for applications and interested eligible Undertakings may submit their applications accordingly.

The IB shall publicise the calls through various media including local newspapers, websites and other media sources. In order to ensure the widest visibility possible, the IB will

collaborate with stakeholders, particularly representatives of the business community, and other Government Entities when publicising the call for applications. The IB will also organise information sessions for prospective applicants, where information regarding the schemes, eligibility criteria and the application process will be given.


## Application Process

Applications may only be filled in and submitted online through the SFD 14-20 application portal. It is important to note that the online Application Portal is customised to work best with the Google Chrome browser.

## Registration and access to the online SFD 14-20 Application Portal

In order to apply, one must first register to the online SFD 14-20 application portal, accessible through: [www.sfd.gov.mt/application](http://www.sfd.gov.mt/application). This process needs to be conducted by the person who will be developing the application on behalf of the Applicant Undertaking. This could either be an individual from within the Undertaking, e.g. an employee / Director / Legal Representative or the Applicant himself / herself in the case of Sole Trader / Self-employed, or an expert entrusted by the Undertaking for this purpose.

A registration window appears on screen as shown in Figure 1.

**First-time Registrants** need to register by clicking the “**Don’t have an account? Register now**” link. (Refer to Annex I “Registering for the first time” of this document for a more detailed step-by-step guide.)

**Registered users** can access the SFD 14-20 application portal by inserting their username and password details. (Refer to Annex II “Accessing the system” of this document for a more detailed step-by-step guide).

A user's **password can be changed** (if forgotten) by clicking on the "Forgot Password?" link. (Refer to Annex III "Requesting a change in password" of this document for a more detailed step-by-step guide).

Following registration, users can fill in and submit an online application form.

**The Applicant's user credentials should not be shared. The system will not allow multiple users to login to the same account at the same time. For security reasons, if multiple users attempt to login to the same account at the same time the account will be disabled.**

## Choosing the correct Call

Once the user account has been successfully created, the user will be directed to log into the System. After logging in, the user will be directed to the *home screen* (shown in Figure 2) and will receive an email containing the User Login and a link to activate the account.

The Home Screen is divided into two sections. The upper section lists the **Open Calls**, and includes a '**New Application**' button. Once the correct call has been identified, in this case it would be 'Call 3 – Start-up Investment Grant Scheme', the user is to click the '**New Application**' button to continue to the actual application form.

The lower section of the home screen contains the details of any application forms that would have been previously created by the user. For new users, the lower section will appear empty as there would be no application forms created yet.

Once an application form is created, the 'View' button found on the homepage, will allow the Applicant to access the respective application form. It is relevant to point out that the system will allow the user to submit more than one project under any open call. In such cases, the user should click on the relevant '**New Application**' button to create an additional application form if/and when required.

Once the button 'New Application' is clicked, a new application is generated and a page as shown in Figure 3 opens up.

This section will request the user to select the relevant **Priority Axis (PA)** and insert the **Project Title** and **Project Summary** accordingly.

The user is to click the **radio button** next to the available **Priority Axis**, in this case this would refer to '**PA 3 – Enhancing Malta's competitiveness through investment in SMEs**'.

**The Project Title is to be created by the user.** The **Project Title** should be a concise description of the project, and suitable to be retained as the permanent project name. Ideally this should not be longer than ten (10) words. **Note: Once the 'Create' button has been clicked the field 'Project Title' cannot be amended.**

**The Project Summary** should be a short non-technical description of the proposed project. This section will serve as a summary of the project and therefore the information should be self-explanatory. (Max 900 characters)

The **"Create"** button will allow the user to proceed to the next step. Once this button has been clicked the information is saved in the system.



There are also two icons at the top-right corner of the screen. These icons are visible in all of the application form screens. The 'Home' button will direct the user back to the home screen. The 'Person' button will give users the option to either change the password or sign out.

## Step by Step Guidelines to complete an Application Form

### Section 1: Executive Summary

The Executive Summary (shown in Figure 4) is a collection of general data that reflect the project at a glance.

This section is cross-referenced with other fields in different sections of the application form. This means that they will be automatically populated by the system once the relevant fields of the application form have been filled in by the user. In fact, all the fields in this section, apart from the 'Project Summary' field, are all greyed out and therefore no input of data will be needed in this section.

The **Call** field will automatically show the **reference** of the respective call for applications.

The **Scheme** field will automatically show the title of the scheme – **Start-up Investment Grant Scheme**.

The **Priority Axis** field will automatically show the title of Priority Axis 3 – **PA3 Enhancing Malta’s competitiveness through investment in SMEs.**

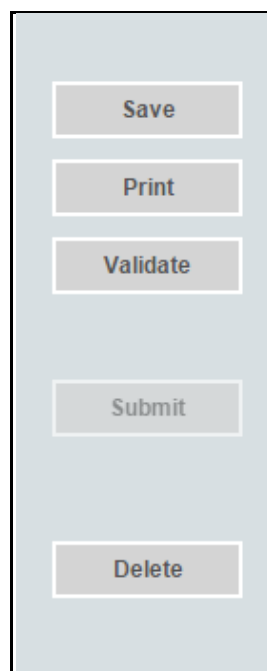
**Project Title** will be showing the title of the project as created by the user previously.

**Project Summary** will be showing the summary of the project as created by the user previously. This is the only field of the Executive Summary that can be amended in this section. (Max 900 characters)

**Project Start Date** refers to the date when the project is envisaged to start (excluding drafting of the application form). This start date will be a provisional start date, as activities can only start after the signing of the Grant Agreement. This field will be automatically filled in by the system once the applicant has completed **Section 4 – Financial Plan.**

**Project End Date** should reflect a realistic timeframe for the implementation of the project and should not exceed 24 months from the date of the project start date, by which date all activities are to be completed. This field will be automatically filled in by the system once the user has completed **Section 4 – Financial Plan.**

On the right hand side of the application form, applicants will find 5 different function boxes: **Save, Print, Validate, Submit and Delete.**

It is important to note that **'Saving'** the document does not mean that the application form has been submitted to the IB, but only that the information has been stored on the system. This means that the application form can be still updated/amended until the final version is submitted. If the user decides to sign out of the application form at any stage, the data which would have been saved will be retained. When the user decides to commence with completing the application form, by clicking the 'View' button in the homepage, the user will be redirected to the 'Executive Summary' section, which is the first section of the application form.

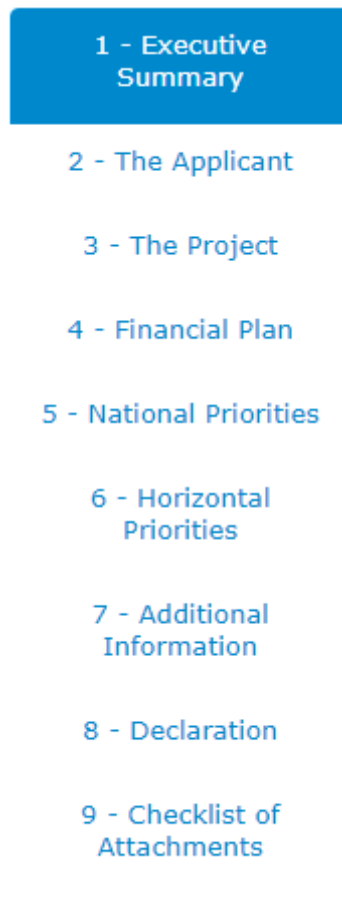
The **'Print'** function will allow the user to print the section that they are viewing. This will allow users to distribute the data internally without having to provide their credentials to third parties. **(Refer to Annex IV for further details on how to export the Application Form in excel, word or PDF).**

On the other hand, the **'Validate'** button should be used when the user wants to verify sections of the application form that have been completed. In order to confirm that the application form is being correctly filled in, it is recommended that sections are validated as soon as all the necessary information has been inputted. When the fields of the application form are filled in incorrectly, or data is missing, upon clicking the 'Validate' button an error notification will appear at the top of the page. The error notification will specify what the error is so that the user can rectify and save accordingly. Therefore, when filling in an application in different stages, the user will be prompted by an error if the 'Validate' button is clicked, as there would still be sections not yet filled in the full application form. If no errors are given, then the information inputted can be considered to be correct. Users are reminded that any changes made to a previously validated section will need to be re-validated.

The **'Submit'** button will only be activated once all the sections have been validated. This function will result in the application being submitted for evaluation.

The **'Delete'** button will result in the permanent removal of an application from the SFD application.

On the left hand side of the application form, the user finds a list of all the sections of the application form. The user can navigate between the different sections by clicking the links shown in Figure 6.

## Section 2: The Applicant

This section refers to the Applicant Undertaking that is seeking assistance through the Scheme.

Section 2 consists of three (3) sub-sections which are described in further detail below:

### Section 2.1: Applicant Details

The section 'Applicant Details' is shown in Figure 7 and the respective data fields are to be filled in by the user as follows:

**Legal Name of Applicant** – The Applicant is to enter in this section its legal name that is:

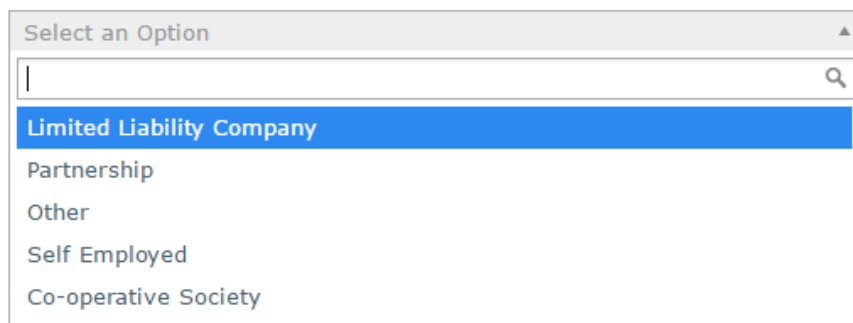
- Limited Liability Companies – the name as defined in the Memorandum of Articles of Association;
- Partnerships and Co-operatives - the name outlined in the deed of partnership should be inserted in this section; and
- Sole trader/Self-employed persons - are to insert the name of the same self-employed person.

**Authorised Representative** – The Authorised Representative is an individual appointed by the applicant Undertaking to enter into agreements on its behalf as outlined in the Memorandum of Articles of Association or pursuant to a Declaration of the Board of Directors. A copy of the Declaration is to be uploaded in **Section 9 of the Application Form**. In the case of Sole traders/Self employed this should be the name of the same self-employed person.

**ID number** – The identification number of the Authorised Representative is to be inserted.

**e-mail Address** – The e-mail address of the Authorised Representative is to be included.

**Legal Form of the Enterprise** – The user is to choose one of the options provided in the drop down menu (see Figure 8).

If the user chooses **'Other'**, then the Legal Form of the enterprise is to be specified in the respective field.

**Registration/Identification Number** – The Registration/Identification Number is the official registration number of the company or partnership in terms of the Companies Act, Chapter 386 of the Laws of Malta or the respective legal framework under which the applicant enterprise is registered. In those instances where the Applicant is not registered under Chapter 386 of the Laws of Malta, the user is to upload the legal document constituting the Enterprise under **Section 9 of the Application Form**. **Sole Traders/Self Employed** should enter their Identity Card Number.

**Date Established** – The user is to specify the Date of Establishment of the enterprise through the following:

- a) for limited liability companies, the Establishment Date shall be the date of registration with the MBR;
- b) in the case of self-employed, shall be considered to be the date the person registered as a self-employed person with Jobsplus;
- c) in the case of partnerships, the establishment date shall be considered to be the date of the deed establishing the partnership;
- d) in the case of associations the date of the Statute establishing the association.
- e) In the case of co-operatives, the establishment date shall be considered as the date of the registration of the co-operative with the Co-operatives Board.
- f) In the case of others, the establishment date shall be considered as the date of registration of the organisation in terms of the applicable law of its establishment.

***One should note that the date of establishment is to be less than 3 years from submission of application. Should any date entered into this field elapse this defined period, then the application will not be validated for submission.***

**Registered Address** – The user is to insert the registered address of the enterprise.

**Post Code** – Insert the respective Post Code.

**Phone Number** – Insert the phone number of the enterprise.

**VAT number** – Insert the VAT number of the enterprise.

In the case of newly established start-ups, where the VAT number has not yet been issued, please insert the wording 'Not yet issued' in the field for 'VAT number'. A copy of the acknowledgement by the VAT Department for the application for the VAT number must be uploaded in Section 9 as Supporting Documentation.

**Website address** – Insert the website address of the enterprise. In case the enterprise **does not** have a website, kindly input 'Not Applicable' in the field.

**Project Manager** – The Project Manager is the person responsible for the implementation of the project. Only **ONE** Project Manager can be responsible for the project at any one time, even if the project is composed of different activities.



**ID number** – The identification number of the Project Manager is to be inserted.

**Position within Enterprise** – The user must provide the Project Manager’s position within the enterprise. In case the Project Manager is someone external to the applicant enterprise, then this is to be specified accordingly.

**Phone number** – Enter the contact number of the Project Manager.

**E-mail address** – Enter the e-mail address of the Project Manager.

**Confirmation by Applicant**

**Users are to note that when Section 2.1 is filled with the relevant details and validated, a notification email shall be sent to the Applicant to confirm the application. Unless the Applicant confirms the application, the system will not enable submission of the application.**

The Applicant needs to indicate the **Size of Undertaking**. The Size of the Undertaking is based on Annex I Commission Regulation (EC) No 651/2014 of 17 June 2014. The regulation can be found here:

Basing on the aforementioned regulation, users are to primarily determine the Linked and Partner enterprises and subsequently fill in the details of the respective enterprises accordingly as shown in figures 9 and 10. Should one need more space where to add any Linked and/or Partner enterprises one can do so by clicking on the ‘Add another enterprise’ button under the respective tables.

In case an Applicant is an Autonomous Undertaking, or it has no Linked and/or Partner enterprises, the user is to insert the words ‘Not Applicable’ in the first row of the respective

tables and a '0' under the column 'Shareholding %'. This will enable the proper saving and validating of data.


One needs to then determine the size of the Undertaking by calculating the Headcount, Turnover and Balance Sheet Total of the Applicant enterprise. This should be done by following the steps explained in the 'User guide to the SME definition'. For easier reference an excel sheet has been created to assist in determining the Size of the Undertaking and this can be accessed from <https://businessenhance.gov.mt/Publications.aspx?tE0CdQZCR0IXrrVIEzwN+IIUwU+CysZq>

The table below also acts as a guideline on how the Undertaking size can be determined.

Following these workings, the user is to then select one of the options from the list provided (refer to Figure 11) to specify the size of the Undertaking.

Following the completion of this segment users must save the application form by clicking on the **'Save'** button found on the right hand side of the screen in order to populate the drop down function found in the next question.

**It is essential for all the fields in this section to be completed for the validation to go ahead.**

Applicants are to provide a copy of the **Audited Financial Statements and/or the Management Accounts** dated within the two financial years prior to the year of submission of the application for the applicant enterprise and all the linked and partner enterprises as specified in the Guidance Notes for the Grant Scheme:

- Audited Financial Statements and/or the Management Accounts dated within the two financial years prior to the year of submission of the application in relation to the applicant and the linked and partner enterprises. No documents would need to be submitted if a copy of these documents is already deposited with the Registry of Companies.

With the respect to the last financial year, the applicant enterprise is to submit a copy of the detailed (not abridged version) of the Audited Financial Statements or the Management Accounts (Profit & Loss Statements/Income Statement and Balance Sheet/Statement of Assets and Liabilities) certified by a Certified Public Accountant. The abridged version may be submitted with respect to the previous year.

In the case of linked and partner enterprises with an obligation to present Audited Accounts/Annual Accounts at the Registry of Companies in terms of the Companies Act (Chapter 386 of the Laws of Malta) no documentation need to be presented subject to the condition that the last Audited Accounts/Annual Accounts declared are not earlier than for the two financial years prior to the year of submission of the application.

In the case of linked and partner enterprises without a legal obligation to prepare financial statements the Management Accounts (Profit & Loss Statements/Income Statement and Balance Sheet/Statement of Assets and Liabilities) certified by a Certified Public Accountant.

In the case of a Start-up established not over 2 years from the date of application not having the above documentation, a Profit & Loss Account/Income Statement, Cash Flow Projections and a Balance Sheet/Statement of Assets and Liabilities certified by a Certified Public Accountant.

In the case of a Sole Trader/self-employed a copy of the Income Tax Return for the last two years together with a Profit & Loss Statement certified by a Certified Public Accountant.

Where required, accounts are to be uploaded through the **Enterprise Accounts** form found at the end of section 2.1.

In order to upload accounts, one is to first select whether the accounts that are going to be uploaded are for the Applicant, or for a Linked or Partner enterprise. The relevant Enterprise names will be then made available in the dropdown list and the appropriate Enterprise is to be chosen accordingly. This dropdown list is populated from the information provided earlier in section 2.1. The accounts files are then to be uploaded by clicking on the Choose File button which will open a window through which the documents can be uploaded. One should note that the annual accounts should be saved in one *.pdf* document or in a *zip* file. When the information has been filled and the correct accounts files chosen, the User can then choose

to save the information by clicking on the 'Save Account' button found on the bottom left of the form. Once the form has been saved one can add the account details of additional linked or partner enterprises by redoing the process.

In order to delete any previously saved entries one must first select the saved entry and then click on the 'Remove Account' button found at the bottom of the form. It is important to be sure before deleting entries as any deleted entries will not be recoverable.

In order to clear the form from any details entered before saving, one can click on the 'Clear' button which is found on the bottom right of the form.

### Section 2.2 - Applicant's core business activities

**NACE Code** – The user is to insert the digits of the NACE code describing the commercial activity of the enterprise. Automatically, the respective description of the activity linked to the particular NACE code will show in the space provided.

Applicants are to note that the NACE classification of an enterprise is usually available in the VAT Information Sheet received together with the VAT Certificate issued by the Commissioner for Revenue. In this regard, enterprises are to ensure that the NACE Code in this VAT Information Sheet truly reflects their actual primary economic activity.

In those cases where applicants do not have such document, they may seek guidance from the Business Register at the National Statistics Office (NSO) in writing in order to determine the respective NACE Code.

As evidence of the applicant enterprise NACE Code, one is to submit either a copy of the VAT Information Sheet or a copy of the communication between the applicant and NSO in Section 9.1 of the application form as *Supporting Documents*.

As for start-up enterprises not yet having a VAT Information Sheet in hand, or any other enterprise which in line with VAT regulation are not issued a VAT number by the Commissioner for Revenue, these are requested to determine their respective NACE classification by referring to the NACE Rev. 2 classification which is available online.

Applicants are then to select the area which the start-up is engaged in by ticking one of the options shown in figure 13.

The start-up is engaged in:

- The production, manufacture, improvement, assembly, preservation, processing of goods, materials, commodities, equipment, plant machinery;
- Biotechnology, Pharmaceuticals and Life Sciences;
- Research and Technological Innovation;

- Information and communication technology (ICT) development activities, software development;
- Eco-innovations, and environmental solutions;
- The creation of tourism products and services as a result of networks created between traditional tourism service providers and the crafts and artisan sector;
- The development and provision of tourism products and services related to emerging niche markets;
- The development and provision of tourism products and services related to the promotion of natural and cultural heritage;
- The development and provision of tourism products and services related to social tourism with specific focus on senior tourists, accessible tourism and active ageing;
- The development of innovative concepts, products and services offered by Boutique Hotels and Palazzini;
- The development , and/or provisions of E-health solutions;
- The development and provision of services and products promoting healthy living;
- The development and provision of services and products promoting active ageing;
- The development and provision of services and products related to child-day care;
- The development and creation of crafts and artisan products;
- Retail activities by self-employed and family businesses engaged in craft;
- Proposing products/and/or services that can be marketed and distributed internationally and which are typically more advanced than those prevailing in their respective industry in terms of technology, know-how and skills.

In this section, one is to provide further details on the core business activities in which the enterprise is engaged in, and provide a background description of the enterprise and its operations. (Max 5,000 characters)

#### Section 2.3: Past Investment Initiatives

In this section, one is to indicate whether the Applicant has or is currently implementing any investment initiatives. These may include projects funded through public sources such as EU and National funds, or privately funded projects. In providing details of such initiatives, the user should only include initiatives implemented within the past **5 years** (from date of application). The user is to provide all relevant details as shown below.

Applicants are to insert data in the lower fields (See figure 14). The data to be inputted includes the **“Title of Investment”**, **“Description of the Investment”**, **“Source of Financing”**, **“Total Investment Cost €”** and **“Project Outcome”**. The upper fields are cross referenced and will be automatically filled in once details are inserted in the lower fields and the **“save experience”** button is clicked.

There is no limit to the number of initiatives that can be recorded in the system. This is described in more detail below.

This section provides three buttons with the following functionalities: to **save the experience**, to **remove the experience** and to **clear the text**. Their function is explained below:

- The **‘Save Experience’** button will allow the Applicant to save the data that was inserted in the lower part of the section. Once the button is clicked, the relevant information will also appear in the upper part of the section. After clicking the **‘Save Experience’** button applicants can re-do the process to add additional experiences.



- The **'Remove Experience'** button will allow the Applicant to remove details of any experiences which might have been saved in the system. Applicants should be careful using this functionality because any deleted record cannot be retrieved. In order to remove an experience the Applicant must click on the enterprise's name (on the upper part of the section) and then click on the 'Remove Experience' button at the bottom.
- The **'Clear'** button has two functions:
  - a) Pressing clear when data is inserted in the fields but is not saved will clear such fields automatically
  - b) If the Applicant selects any of the already saved experiences, by pressing clear, the selected experiences will be removed.

A **blank entry** signifies that the Applicant has **no previous experience in the implementation of investment initiatives**. This section may be left blank, however, if any details are inserted all fields will become mandatory.

This section introduces the Applicant Undertaking to the project itself. The application will automatically show the Specific Objective that the call is tied to as shown in figure 15.

#### *Section 3.1.1: Proposed Investment Initiative*

The user must give a description of the proposed project, specifying its main characteristics and what it is proposing to attain. In line with the Business Plan, one is to identify what this project intends to achieve and how the enterprise will benefit from this action. (Max 5,000 characters)

#### **Impact on enterprise should funding not be secured**

Describe how the Undertaking would be affected if the project funding is not secured. The user may refer to examples such as, amongst others, the eventual downsizing of the project, the possibility of implementing the planned activities over a lengthier timeframe by

postponing activities to a later date or opting not to implement these activities altogether.  
(Max 5,000 characters)

### **Section 3.2: Project Excellence**

The Applicant is to describe the excellence of the project by **describing the main characteristics of the proposed project**, in terms of:

**a. The holistic nature of the project.**

Specify how the proposed initiative is **holistic in nature**, outlining the synergy between the different activities to be undertaken through the project and any other complementary activities. Applicants must demonstrate how the proposed project fits in the Undertaking's overall business strategy, and the extent to which this is addressed by the project. (Max 5,000 characters)

**b. How ambitious the project is by proposing products and/or services that are more advanced than those present in the market.**

In this section, the user is to describe the extent of the novelty and the technology level of the proposed products and/or services. By using data from the Business Plan one should identify whether the project will be presenting products/services that are more advanced than those present in the market, and presenting a novel concept to the respective sector. (Max 5,000 characters)

**c. The extent that the project is addressing an identified gap in the market for the specific sector.**

Applicants should indicate the extent to which the project will be addressing gaps in the enterprise's specific sector. Using data from the Business Plan the user should focus on the novelty of the concepts and approaches to be introduced by the project. Also one is to highlight whether the project will be targeting emerging markets and that have high internationalisation potential. (Max 5,000 characters)

### Section 3.3: Project Impact and Sustainability

In this section the applicant should outline the project's impact on the enterprise in terms of:

- a. **Potential future growth and sustainable economic viability leading to long term market resilience.**

One must describe how the project will impact its potential **future growth** and the **sustainable economic viability** of the enterprise. Applicants should make reference and extract information from the business plan, with reference to timelines, projections, etc. (Max 5,000 characters)

- b. **Retention of present employment and potential future increase in employment.**

In this section describe the impact that the project will have on the **retention of current jobs** in the enterprise and the **potential to create new job opportunities**. Reference should be made to Full Time Equivalent (FTE) data and take into account a reference period up to three (3) years following the completion of the project. The user should include projections, forecasts and timelines identified in the Business Plan. Reference should also be included to the potential percentage increase in employment (number of FTE) in relation to the present staff complement. (Max 5,000 characters)

- c. **Improvements in the Undertaking's business model.**

The user must define how the **business model will improve** as a result of the project. Using data from the Business Plan, elaborate on how, as a result of the proposed project, the Undertaking will realise a more sustainable business model. This should include projected outcomes to achieve this business improvement. (Max 5,000 characters)

### Section 3.4: Project Quality and Efficiency of Implementation

- a. **Identify the level of management and control systems in place.**

The work plan should include an outline of the **level of management and control systems**, including any internal standards and systems that are in place within the enterprise, and the **methodologies** to be adopted during the implementation of the proposed project. The user should present any documented methodology it might have in place (this does not necessitate certified quality standards, but a documented methodology that offers assurance through checks and balances), and upload it in **Section 9 of the Application Form**. (Max 5,000 characters)

**b. Level of Private Match Financing and additional investment addressing complementary actions.**

The user must provide evidence of the source and **level of Private Match Financing** to see this project through. This should include whether the source is in the form of Private Equity, from the Applicant's own financial resources, bank loan, crowd funding, or others.

The user is requested to describe any **complementary actions** that the Undertaking will be engaging in or implementing in tandem to the proposed project. A detailed description of these actions should be provided and defined in terms of how they will **add value to the project**. Any supporting documentation is to be uploaded in **Section 9 of the Application Form**. (Max 5,000 characters)

**c. Describe the level of capacity and allocation of resources towards the project.**

The user must identify the **level of capacity** and **resources** that will be allocated to the implementation of the project. Reference should be made to both the human and operational resources that the Applicant has and how these will be used during project implementation. One should describe how the project's activities will be operated and maintained after the project's completion, specifying the structures that are, or will be put, in place to implement the planned investment.

The **roles and functions** of any identified personnel must also be defined in relation to the proposed project. (Max 5,000 characters)

### **Section 3.5: Project Risk Assessment**

**a. Identify and describe any risks that might impact the implementation of the project and indicate the probability of these risks happening.**

Applicants should indicate the **identified risks**, the **level of risk** the proposed project is exposed to and the **probability** of these risks happening. Applicants should consider the level of complexity that the project entails. For example, applicants should take into account whether any of the equipment/activities intended to be procured shall require customisation or whether these may be available off the shelf. The introduction of complex customized products/activities will raise the implementation risk. (Max 5,000 characters)

**b. How do you intend to mitigate these risks?**

Applicants should take into account all the risks which have been considered and describe what measures will be set up to ensure that these **risks are minimised**. (Max 5,000 characters)

## Section 4: Financial Plan

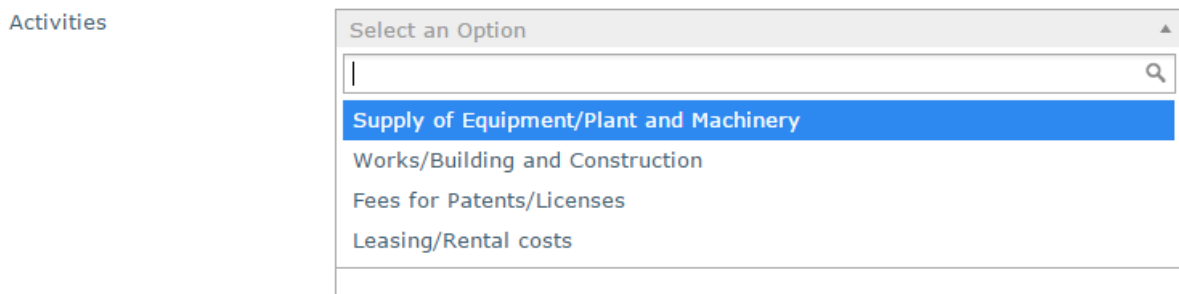
Figure 17: Section 4

The project proposal must include a comprehensive budget breakdown. In this section, which is shown in figure 17, the user is to choose the activity (from a pre-defined list), insert a sub-activity in relation to the activity, and then for each respective sub-activity one is to insert a start date and end date, describe the sub-activity, insert any comments, and define the budget in the provided fields accordingly. The total costs of the project will be automatically calculated through the summation of costs of all the Sub-activities inserted by the user. This is further explained field by field below.

### Section 4.1: Financial Plan

The user should select the relevant Activity that will be implemented from the drop down menu under the 'Activities' field. To limit errors, this menu will provide a pre-determined list of activities that are eligible under this Scheme.

Once the activity has been identified (see figure 18), the user is to describe the sub-activity/ies linked to that activity. For example, if the activity 'Equipment/Machinery/Plant' is chosen, the user may include 'Conveyor belt' as a related Sub-activity.

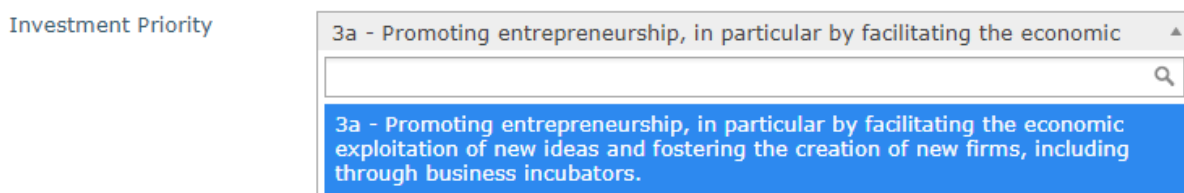

## Start and End date

The user is to insert the start and end date for each Sub-activity by choosing the dates from the automatic calendar that pops up when the field is clicked on.

One needs to ensure that the earliest start date and last end date of the project do not exceed 24 calendar months.

## Description of the Activity/sub-activity

The Applicant is requested to concretely **describe** what each sub-activity entails, and define the implementation of that sub-activity.

## Comments

Applicants are to provide any comments that may be deemed necessary such as reference to item specifications or clarifications in relation to any ineligible costs that may still be necessary for the project implementation. If the Applicant does not have any comments, then 'Not Applicable' is to be inserted.

In this section, the user should specify the costs (in EUR) in the fields provided.

The '**Eligible**' costs are to be inserted in the respective field. The VAT for both eligible and non eligible costs is to be invariably inserted in the '**VAT Non Eligible**' field.

The '**Non Eligible**' costs indicated under this section need to reflect any expenditure (excluding VAT) related to that Sub-activity but which is ineligible for funding as specified in the scheme Guidance Notes.

The **Gozo Contribution Financial Plan** will be greyed out if the user did not provide an address in Gozo in Section 3.1 of this application. ## Section 9: Checklist of Attachments

It is the responsibility of the Applicant to ensure that **all** the necessary documents mentioned throughout this Application Form and the respective Guidance Notes are included under this Section. For ease of reference a checklist has been provided in the application form.

The Applicant is required to upload the following mandatory documents identified in the above checklist with the application form, as specified in the respective Guidance Notes:

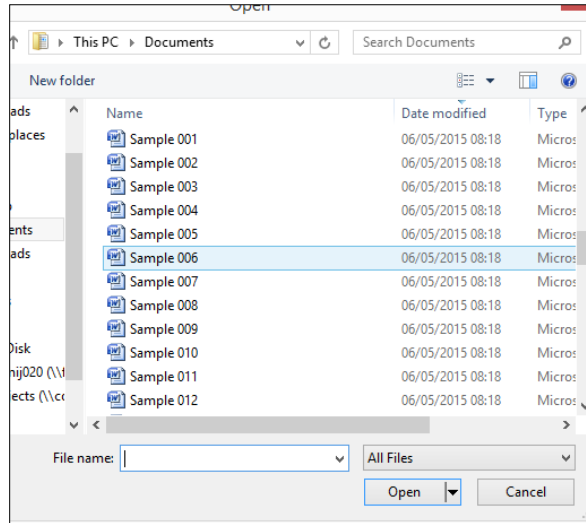

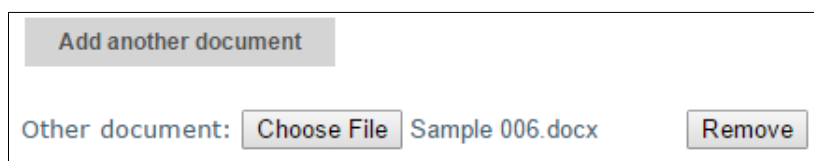
**Figure 23: Choosing a file to upload**

When the file is chosen (and the User clicks on 'Open') the system returns to the uploading screen where the file is now shown in column 3 of the table. It is important to point out that at this stage the file is still not uploaded in the system. In order to upload the file in the system the User will need to click on the '**Save**' Button (on the right of the screen) following which the file will be shown as uploaded (in column 2).

At this stage the User may opt to either continue inputting other documents (by clicking on the relevant '**Choose File**' buttons in the other rows), viewing the document (by clicking on the '**View**' button) or removing the document (by clicking on the '**Remove**' button).

The User will have the option to also upload documents which are not listed in the information table. This can be done by clicking the 'Add another document' button (figure 24) beneath the previously mentioned information table. On clicking such button the User will be prompted to choose a document to be uploaded.

Once selected, the document name will appear adjacent to the 'Choose File' button (as shown in figure 24).

At this stage the document is not actually uploaded to the system. This will take place only when the 'Save' button is selected. Before the application form is saved, the User can click on the 'Remove' button and the selected file will be removed (without being saved). Alternatively, clicking on 'Choose File' will allow the User to select another document which will replace the one previously selected.

Once the User is satisfied that the correct document to be uploaded has been selected, one may proceed with saving the application form (following which the document will be uploaded). The User will know that the upload has been successful because the document will appear as 'Other' in the information table. There is no limit on the number of 'Other' documents that can be uploaded in the system.



## Annex I: Registering for the first time

Step by Step guidelines to filling in the user profile window follow:

**Organisation Name:** This section should show the full legal name of the beneficiary Undertaking which intends to submit the project. A project must be linked to only **ONE** Undertaking.

**First Name and Last Name:** This section should show the name of the Authorized Representative who will be submitting the proposal on behalf of the Undertaking and who will act as the main point of contact. This individual will hereinafter be referred to as the “**Applicant**”.

**Address & Post code:** The Enterprise registered address and Post Code are to be inserted in these sections.

**Telephone Number:** The Applicant's work telephone number is to be inserted in this section.

**Mobile Number:** The Applicant's mobile number or that of his/her direct superior is to be inserted in this section. In cases where this is not possible, the number '0' should be inserted.

**ID number:** The Applicant's Identity Card number is to be inserted in full (e.g. 12345M).

**VAT Number:** The VAT number of the Enterprise, as per VAT certificate, is to be inserted in this field.

**CORP Account (if any):** This data field is applicable to Applicants that are government officers. Applicants that do not have a CORP account are to leave this empty and the system will automatically generate a User account.

**Email Address:** This section should show the Applicant's (the Authorized Representative) contact email address. The registration process will require the insertion of a valid and official email address in order to be completed effectively. Ideally, generic email addresses should be avoided.

**Password:** The Applicant is to insert a password.

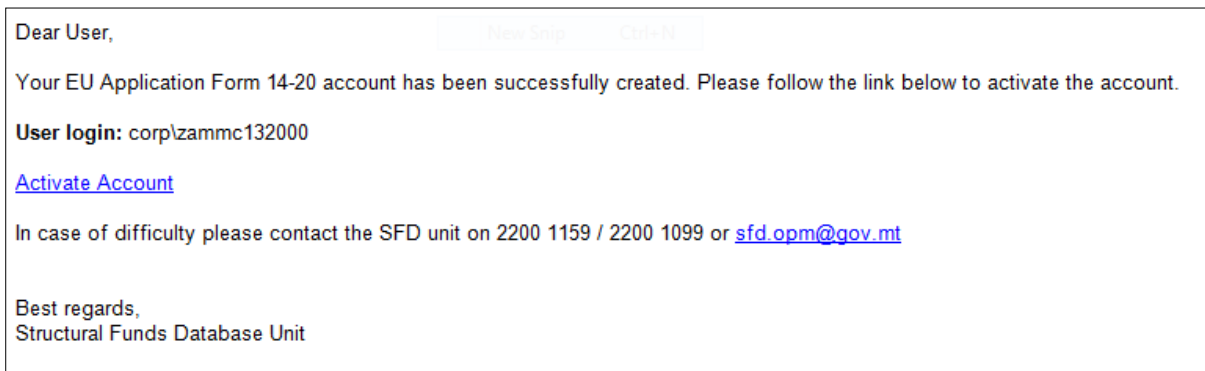
Note: The password chosen must comply with the following established criteria:

- must be at least eight (8) characters long
- must contain at least one character from three of the following four categories:
  - English uppercase characters (A through Z)
  - English lowercase characters (a through z)
  - Numbers (0 through 9)
  - Symbols, for example + = ( ) & ! ? > <
- Passwords must NOT contain three (3) or more consecutive characters of the Applicant's login, name or surname.
- New Passwords must be different from the last recently used password

- **Confirm Password:** The Applicant is to re-type the password to ensure that this has been inserted correctly.

When **all** the data fields have been inputted the Applicant can proceed by clicking on the **'Register'** button. The user will be prompted with error messages if any data field is left incomplete or is filled in incorrectly.


Upon successful registration an automated email will be generated from the SFD system to the e-mail address that the Applicant provided in the user registration form. This email (as shown in figure 26) will inform the Applicant that the SFD14-20 account has been created successfully and will provide the Applicant with a link to activate the account.


If you are already registered you can proceed to access the system by inserting the Applicant username (provided upon registration) and the password and clicking on the Submit button.



## Annex III: Requesting a change in Password

This function should only be used when the Applicant has forgotten his/her password or when he/she has doubts as to whether the security of his/her password has been compromised.

By clicking the **Forgot Password** link the Applicant is directed to a screen where he/she is asked to insert his/her Applicant name. In this case the Applicant must first insert the username generated following registered.


**Figure 28: Forgot Password Screen**

On pressing the Submit button the Applicant will be informed that an email has been sent to the email address used in the registration process. The user can then follow the instructions and link provided in the e-mail to reset the account password.

Note: There is a possibility that Applicants may also receive a generated email to reset the password even though they did not request it. This may be due to another Applicant trying to access the application form using the Applicant's username name and requesting to reset the password. In such cases the details of the request are recorded (for auditing purposes) and the Applicant should disregard the password change prompt and continue using the current password to log onto the system. In such circumstances it is strongly recommended that the issue is reported to the Managing Authority for further investigation.

**REMINDER: usernames and passwords are NOT to be shared.**

If the request to reset the password is genuine, on clicking the reset link the Applicant is directed to a screen where he/she is prompted to insert a new password as seen in the below figure.

## Annex IV: Exporting Application Form to .pdf

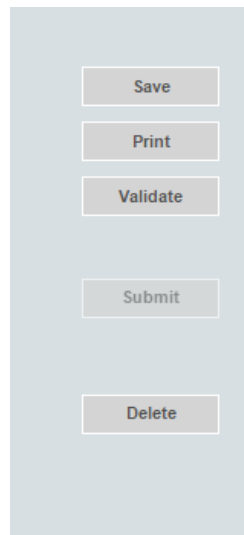



Figure 30: Exporting Application Form

Applicants may generate a copy of the online application form, in PDF format, at any stage of the application form process. This can be done by clicking on the print functionality button that is available on the right hand side of the screen (see figure 30 below) which in turn will generate a screen informing the user that the application form is being exported (see figure 31). Applicants are to click on the “floppy disk” icon found at the top right corner of the screen (see figure 31) and may generate this application form in Excel, Word or PDF format as required.

## **Annex V: Declaration by Trustee or Fiduciary in Relation to a Company within a Group**

Applicants who have linked or partner enterprises represented by Trustees or Fiduciaries must submit a declaration with the information of these enterprises. The declaration form can be found from: <https://businessenhance.gov.mt/Forms.aspx?tE0CdQZCR0IJ0giubI5U5I+WIsaAYSFK>. A declaration for each enterprise represented by Trustees or Fiduciaries must be submitted.

The declaration should be filled in by the Legal Representative of the Trustee/Fiduciary Company.

On the upper left hand corner of the declaration the person filling in the declaration should insert the Date of Declaration and the name of the Company applying for the grant in the available fields.

In the left hand column the Company Registration number, or in the case of an individual, the ID Card No., of all involved is to be listed. In the right hand column the name of the Company/Individual/Entity should be filled in.

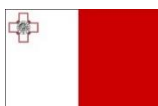
The declaration must then be signed by the Legal Representatives of the Trustee/Fiduciary Company.

Once the declaration has been signed it should be scanned and uploaded in Section 9 of the online Application Form.

**Failure to submit the Declaration Form, or the submission of an incomplete Declaration Form will render the Application Form ineligible.**
