SCOPE AND LEGAL BASIS

The European Migration Network is an EU network of migration and asylum experts who work together to provide **objective**, **comparable and policy-relevant information**. The EMN was legally established under Council Decision 2008/381/EC, amended by Regulation (EU) No 516/2014 of the European Parliament and of the Council in April 2014.

The European Commission (DG Home) coordinates the European Migration Network.



STRUCTURE OF THE EMN

The EMN is made up of different entities such as:

- The EU Commission
- All EU MS NCPs plus Norway
- EMN Steering Board

Expert groups encompass:

- Return Expert Group
- Info Working Group

Multi-Level Network comprises:

- EURINT European Integrated Return Management Initiative Network

STRUCTURE OF THE EMN

- The EMN is funded by the Asylum, Migration and Integration Fund (AMIF), and a two year budget is allocated to support EMN NCPs.
- EMN Work Programme is developed by the EMN and is approved by the EU Commission.
- The EMN Steering Board provides strategic guidance on EMN activities. It is chaired by the EU
 Commission and comprised of one representative from all EU MS as well as observers from EU
 Parliament and Norway, while the EU Commission is assisted by service providers for
 coordination.

EMN STUDIES IN 2018

- Integration Policies for Third Country Nationals across EU Member States and Norway, with focus on Labour Market Integration Measures.
- Impact of visa liberalisation on countries of destination.
- Attracting and retaining international students and researchers in the EU.
- Beneficiaries of International protection travelling to their country of origin: challenges, policies and practices.



RESEARCH OUTPUTS IN 2018

Outcomes of the Study on the Impact of Visa Liberalisation on Countries of Destination

- ➤ Visa liberalisation led to an immediate increase in short-term travel to the EU Member States and Norway from visa-free countries, an increase in control activities to avoid the misuse of visa liberalisation and an immediate reduction in the workload of consulate staff.
- Following visa liberalisation, there has been an increase in the number of resident permits issued to nationals of the eight visa-free countries, mostly for remunerated activities.
- > Several Member States reported an overall increase in the number of asylum applications from visa-free countries following visa liberalisation. Most of these applications received a negative decision.
- > The number of visa-free nationals overstaying their maximum period allowed increased after visa liberalisation in Member States.
- Available data was limited to establish a clear link between visa liberalisation and the facilitation of irregular migration.
- Most Member States did not report specific challenges related to illegal employment after visa liberalisation was introduced.



RESEARCH OUTPUTS IN 2018

Outcomes of the Study on Labour Market Integration of TCNs in the EU Member States

- ➤ Most Member States were found to have dedicated labour market integration policies in place, targeting multiple migrant groups, including first generation third-country nationals.
- These policies combine both mainstream and tailored labour market integration measures: mainstream measures help to ensure third-country nationals receive equal access to general (public employment) services, while tailored measures give specific support needed to help migrants to succeed in a job and a new society, such as language or job qualification training.
- ➤ The three most common obstacles to labour market integration relate to the accreditation of job qualifications and assessment of skills; discriminatory behaviours in recruitment processes; and insufficient language skills.
- > Public sector integration measures focus primarily on the phase before accessing employment, such as preparing and searching for a job.
- Private sector measures aim more specifically at integrating the migrant worker into the workplace, including training and enhancing intercultural relations in the workplace.



RESEARCH OUPTUTS IN 2018

Outcomes of the Inform on Social Benefits and Rights for Beneficiaries of International Protection

Key Findings

- ➤ Differences remain across the Member States with respect to the levels of social benefits and rights granted to beneficiaries of international protection; however, it is clear that Member States uphold certain minimum levels of the respective social benefits and rights.
- > All Member States treat access to education and access to healthcare as a fundamental right.
- Arrangements for granting respective social benefits and rights vary among Member States, across all five social benefit categories (education, health care, housing, family reunification and financial allowances).
- ➤ Most Member States appear to provide the same access to and/or conditions for education, health care, financial allowances housing, family reunification for refugees and for those who are granted subsidiary protection.
- In the majority of Member States, governmental authorities and NGOs cooperate in providing different social benefits for beneficiaries of international protection.

RESEARCH LAUNCHED 2018

Study on Beneficiaries of International Protection Travelling to their Country of Origin: Challenges, Policies and Practices

The aim of study is to procure information about the reasons for beneficiaries of protection travelling to their country of origin.

This is in view of the fact that:

- Both international refugee and EU Asylum law encompass several grounds, whereby protection status may
 come to an end in circumstances, where it is apparent that protection is no longer necessary nor justified,
 being referred to as cessation grounds.
- Furthermore, this study aims to analyse the possible consequences of such acts on the international protection status and residence rights of the persons concerned.

ACTIVITIES IN 2018

• Cluster Meeting held on the 27th April - This meeting offered the opportunity to EMN National Contact Points to share their experiences in reaching national policymakers. NCPs from Hungary, Poland, Sweden and UK attended the meeting. National policymakers from the Maltese government shared their own perspective by expressing their information needs and giving examples of relevant experiences. Focusing on challenges encountered and solutions to be addressed, the cluster meeting was an occasion for mutual learning among participants.





ACTIVITIES IN 2018

• **Seminar** on "The Involvement of Academics and Students at UM in EMN" held on 26th June 2017. It aimed at bringing academics and students together with EMN MT NCP, while focusing on how to engage academia and students within the European Migration Network. The outcome was a positive one, with academics stating that, primarily there was not enough knowledge about the European Migration Network.





2017-2018 CLOSURE

- Programme ended on 31st December 2018
- Utilisation of funds approx. 90% i.e. 215,000 euro out of 236,000

EU Action Plan on Return	A document presenting a series of concrete actions to enable EU Member States and the European Union to substantially improve the efficiency of their return system.
European Agenda on Migration	A strategic document of the European Union presented in May 2015 outlining a comprehensive approach to migration management addressing the asylum and migration challenges as well as defining steps to be taken to ensure strong borders, fair procedures and a sustainable system able to anticipate future problems in the context of asylum and migration.
European migration liaison officer (EMLO)	A specialised liaison officer seconded in EU Delegations in third countries tasked to coordinate and represent EU interests in the field of migration with the aim of maximising the impact of EU action on migration in third countries and enhancing the engagement of key countries of origin and transit on the entire spectrum of migration issues.
