



By Gender





Status of Claims for Reimbursement







Communication Actions

- The Annual Event for 2015 shall focus on an Information Campaign highlighting achievements in 07-13 Programming Period whilst promoting the new Programme.
- The Information Campaign is expected to include: Media advertising, Audio-visual products and the use of other publicity/information tools.
- A number of promotional items were passed on to MEUSAC to be distributed to school children during summer school activities.
- Attendance to the 40th Informal Network of ESF Information Officers (INIO) network meeting in Brussels on the 25th - 27th February 2015. The 41st INIO meeting will be held in June 2015.





Training and Capacity Building

- The Planning and Priorities Co-ordination Division (PPCD)
 organised a Capacity Building event for PPCD staff on Friday 16th
 January 2015.
- A seminar regarding the Closure of the 2007 2013 Programming Period was held on Friday, 23rd January 2015 by PPCD.
- Structural Funds Database 2007-2013 (SFD 07-13) ongoing
- Four Information session on Audit Findings detected by the Audit Authority during 2014 were organised by PPCD on the 16th, 17th and 18th February 2015.






Training and Capacity Building

 The Planning and Priorities Coordination Division (PPCD) organized 4 induction training sessions which were held on the 26th March, 2nd, 9th and 16th April 2015











PARLIAMENTARY SECRETARIAT

- Wave 7 report was received on 28th April, 2015
- The target population for Wave 7 consisted of all persons who participated in courses or training projects co-financed by the ESF between 1st February 2014 and 31st July 2014
- A total of 2,191 persons were eligible to participate in the survey
- Initial analysis include:
 - 73.1% of participants attributed the positive change in their labour status to the training they received
 - 65.2% of participants claimed that ESF training contributed towards maintaining and/or enhancing their employability while 94.5% of participants claimed that ESF training improved their skills and knowledge
 - 92.9% believed that the ESF training received would be beneficial in the future

Thematic Evaluation

• The Thematic Evaluation for Operational Programme II was initiated within the context of Article 47 of Regulation (EC)1083/2006 as detailed in the Evaluation Plan for Malta's programming period 2007-

- Deliverable 1 was approved on 10th November, 2015, following its presentation to the Monitoring Committee
- During Deliverable 2, the evaluators has organised five focus groups meetings and held several interviews with selected Project Leaders
- The draft report was presented to the Managing Authority in April, 2015
