



**PRE-ANNOUNCEMENT OF CALLS FOR PROJECT PROPOSALS UNDER
European Regional Development Fund 2021-2027**

The Parliamentary Secretary within the Ministry responsible for European Funds would like to pre-announce the following calls for project proposals under the Priority, Policy Objective (PO) and Specific Objectives (RSO) listed below.

Priority 3: PO 4 - A more social and inclusive Europe implementing the European Pillar of Social Rights

RSO4.5 – Ensuring equal access to health care and fostering resilience of health systems, including primary care, and promoting the transition from institutional to family-and community-based care (ERDF)

Note: This call shall specifically focus on the **investment in specialised recreational facilities for persons with a disability or illness and their families** and it is targeting **only Non-Government Organizations in the Health Sector**.

RSO4.6 – Enhancing the role of culture and sustainable tourism in economic development, social inclusion and social innovation (ERDF).

Note: Two separate calls shall be issued:

- **A call targeting only Non-Government Organizations** which shall specifically focus on the **protection, development and promotion of public tourism assets and tourism services**.
- **A call targeting only Ministries, Government Departments and Public Sector entities** which shall specifically focus on the **protection, development and promotion of cultural heritage and cultural services**.

- **Nota:** Din is-sejħa se tiffoka speċifikament fuq l-investiment f'faċilitajiet ta' rikreazzjoni speċjalizzati għal persuni b'diżabbiltà jew morda u l-familji tagħhom u se tkun immirata biss għall-Organizzazzjonijiet Non Governattivi (NGOs) fis-Settur tas-Saħħha.

RSO4.6 – It-tiċhi ħtal-irwol tal-kultura u t-turiżmu sostenibbli fl-iżvilupp ekonomiku, l-inklużjoni soċjali u l-innovazzjoni soċjali (FEŽR).

Nota: Se jinħarġu żewġ sejħiet separati:

- Sejħa li tkun immirata biss għall-Organizzazzjonijiet Non Governattivi (NGOs), li se tiffoka speċifikament fuq il-protezzjoni, l-iżvilupp u l-promozzjoni ta' assi pubblici tat-turiżmu u s-servizzi **tat-turiżmu**.
- Sejħa li tkun immirata biss għal Ministeri, Dipartimenti tal-Gvern u entitajiet tas-Settur Pubbliku, li se tiffoka speċifikament fuq il-protezzjoni, l-iżvilupp u l-promozzjoni tal-wirt kulturali u s-servizzi kulturali.
