



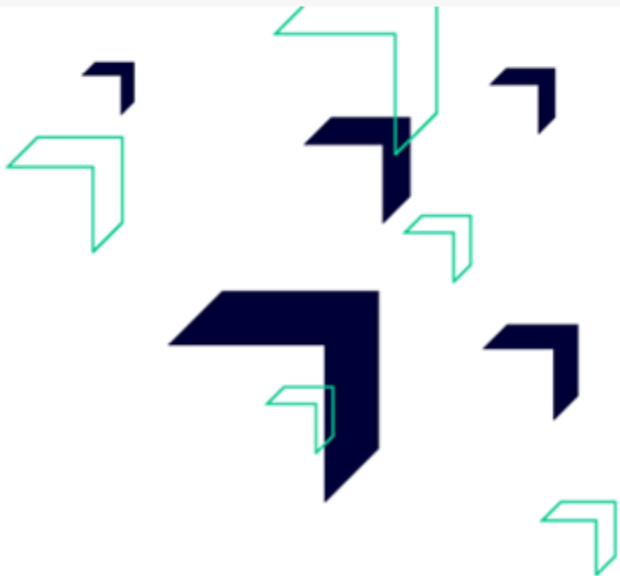

Overview

- A total of 15 Calls for Applications started being launched under all AMIF/BMVI/ISF Programmes since April 2023.
- Focus of first calls was on thematic areas contributing towards strengthening the common European Asylum System under AMIF, enhancing the European Integrated Border Management under BMVI and improving the exchange of information between competent authorities and relevant Union bodies under ISF.
- The majority of the launched calls for applications were restricted in view of the nature of the activities foreseen, in line with the respective Programmes.
- Urgency to launch applications prompted by regulatory commitments - Article 17 (AMIF), Article 14 (BMVI & ISF) stipulating that where at least 10% of the initial allocation to a programme is covered by payment applications, the Member State will be eligible for an additional allocation for its programme as part of the Mid-Term review.

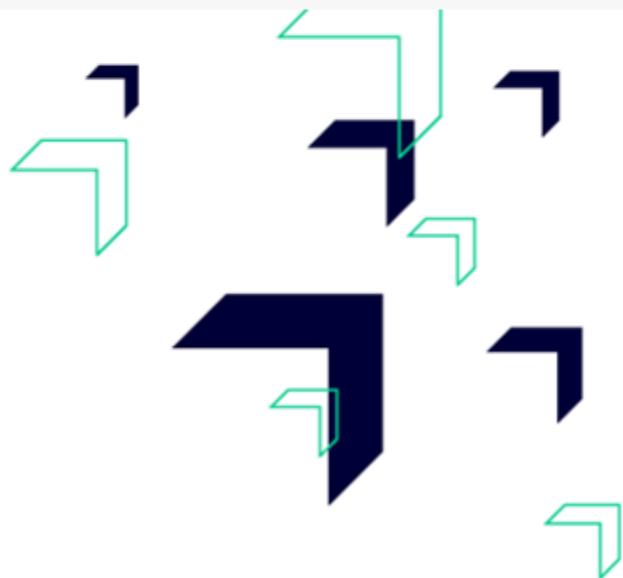
