IMPORTANT NOTICE

- **Call IV: Investing in Specialised Recreational Facilities for Persons with a Disability or Illness and their Families**, launched under Priority 3, RSO 4.5 of the ERDF/CF/JTF Programme 2021-2027 on 22nd October 2023.
- **Call V: Setting up of Industrial Facilities, Including the Development of a Business Incubation Centre**, launched under Priority 1, RSO 1.3 of the ERDF/CF/JTF Programme 2021-2027 on 22nd October 2023.
- **Call VI: Enhancing and Valorising Malta's Tourism Product**, launched under Priority 3, RSO 4.6 of the ERDF/CF/JTF Programme 2021-2027 on 5th November 2023.

Clarification on the need for Financial Studies

The following financial studies are required depending on the value of the project being proposed and whether the project is expected to generate revenue:

- **Financial Assessment** in the case of revenue-generating projects up to €1,000,000;
- **Financial Feasibility Study** for all projects from €1,000,001 up to €5,000,000; or
- **Cost Benefit Analysis (CBA)** for all projects exceeding €5,000,001.

Applicants are also to submit together with their project proposal, the relevant checklists for the Financial Studies to be completed by the Applicant and the Consultant that prepared the applicable financial study.
