The Ministry for European Funds, Social Dialogue and Consumer Protection would like to pre-announce the following call under the Rural Development Programme for Malta 2014 2020:

- **Measure 1.1: Support for vocational training and skills acquisition actions**

This call is targeting entities or bodies that will provide knowledge transfer and/or information to persons engaged in the agricultural and/or food sectors and land managers.

- **Measure 2.1: Support to help benefiting from the use of advisory services.**

This call is targeting Farm Advisory Services (FAS) providers with the aim of helping farmers better understand and meet the EU rules for inter alia environment, public and animal health, animal welfare. The call is open to those registered under the Farm Advisory Service Registration Board (FASRB):

- **Measure 3.1: Support for new participation in quality schemes**

This call will support groups of producers to organise information and promotion activities of National and European Union (approved) quality schemes implemented in the internal market.
