COMMON AGRICULTURAL POLICY 2023-2027**

The Ministry responsible for European Funds would like to announce that it is launching a call for project proposals in the following area:

Specific Objective 2: Enhance market orientation and increase competitiveness, including greater focus on research, technology, and digitalisation.

Intervention 73.5: On-Farm Productive Investments (Simplified scheme up to a maximum of €15K grant)

This call targeting farmers, whether natural or legal persons, who are registered as farmers on the Directorate of Agriculture database, Group of Farmers (including inter alia partnerships, cooperatives).

The call will close on **19th June 2024 at noon.**
