

The Ministry responsible for EU Funds launches the call for applications under the European Social Fund+ 2021-2027 in the following areas:

Equal Access to Quality Social and Healthcare Services - supports initiatives that focus on the improvement and training for health professionals

Integration of Third Country Nationals - facilitates the socioeconomic integration of TCNs, through initiatives steered by public entities and voluntary organisations which focus on the longer-term integration and inclusiveness of various vulnerable target groups, including TCNs

Gender Balanced Labour Market Participation - supports activities aimed at achieving a more balanced labour market, with a primary focus on women, given the lower female participation rate in the labour market when compared to men



Number of Posts – January to September 2024




The major attraction was an **immersive room** with six distinct productions about some of the most successful projects and how European Funds transformed Malta throughout the past twenty years.

- Closure of 2014-2020 Programming Period Plans: the Fondi.eu team is promoting 2014-2020 projects during a number of public events over 2024 and continuing into 2025
