173.4 - Off-farm Productive Investment



- A total of 27 applications were received requesting a budget of €12,891,948.34
- The Selection Process has been concluded, and 10 Award Letters were issued with a total budget awarded of €7,490,748.96
- This intervention is considered as fully committed.

173.3 – Off-Farm Infrastructure Rural Roads for Competitiveness



- A total of 4 applications were received requesting a total budget of €7,647,382
- The Selection Process has been concluded, and 3 Award Letters were issued with a total budget of €7,343,294.06
- This intervention is considered as fully committed.

173.5 - On-farm Productive Investments



(up to 15K - Small Investments Scheme)

- In April, the Small investments intervention was launched where the grant amount was capped at a maximum of €15,000
- As part of the simplification efforts this scheme had a short application with specific simpler selection criteria.
- A draft budget system is being used.
- 488 applications were received requesting a total budget of €4,523,910.03.
- Eligibility checks have been concluded and the selection process is in its final stages.

Simplification

Simplification Actions



- Launched an online application portal
- Where possible, reduced the documentation requested with applications, ensuring that requested information is relevant and proportionate
- Documentation available via data portals/registers is no longer requested from the applicant
- Launched calls for project proposals using SCOs to simplify the reimbursement phase
 - On-farm productive investments small scheme, training, advice, indirect costs across the board, per diem and travel

Simplification Actions



- Simplifying of Guidance Notes, Selection Criteria and application form, as well as the applicable management verifications
- Ongoing efforts on the update of the control and management system for the CAP SP, together with the PA, with respect to EAFRD non-IACS interventions
- Simplified and updated the Change Request procedure under both the RDP and CAP SP

Planned and Ongoing Simplification Actions



- Creating and simplifying templates of the Guidance Notes, the application form, and the Grant Agreement
- Issuing SCOs targeting different interventions (on-farm productive investments, both large projects and a targeted scheme encompassing viticulture, administrative costs for LAGs, staff costs)
- Extending the subrogation principle across different interventions
