Aim of the AMIF Programme

- ➤ 1 Policy Objective of the AMIF Regulation reflected through 4 Specific Objectives and Technical Assistance.
- ➤ Total budget of AMIF Programme: €52.4 mil (EU+MT).
- ➤ Adopted by the European Commission 7th September 2022. Recent adoption date: 20th September 2023.

Policy Objective of the Fund: contribute to the efficient management of migration flows and to the implementation, strengthening and development of the common policy on asylum and the common immigration policy, in accordance with the relevant Union acquis and fully respecting the international obligations of the Union and the Member States arising from the international instruments to which they are party.

Novelties introduced for the 21-27 AMIF Programme



- i. The AMIF Programme is regulated by the Common Provisions Regulations
- ii. Enables the use of different co-financing rates, depending on the actions foreseen in the Programmes, in line with Article 15 of the AMIF Regulation
- iii. The Programme contributes to specific objectives rather than national objectives for simplification purposes.
- iv. Includes a performance methodology delineating the milestones and targets to be achieved by 2024 and 2029 respectively.
- v. The assessment of the Enabling Conditions, and fulfilment which needs to be ensured throughout the 2021-2027 programming period.
- vi. Different EU regulatory parameters, EU objectives and national context.
- vii. Presents an intervention logic based on the main priorities/development needs and types of actions identified in the Programme.
- viii. Aims to strengthen the use of simplified cost options.

Looking Forward



Mid-term review of the AMIF, BMVI and ISF Programme

In accordance with the legal basis of all three Programmes, Member States become eligible for additional funding once at least 10% of the initial allocation has been covered by a payment application. Malta has successfully secured this additional funding for all three programmes.

The reprogramming will take the form of a standard amendment in accordance with the usual procedure whereby the MS submits a reasoned request for programme amendment, as stipulated in the Common Provisions Regulation.

The mid-term allocation for AMIF and BMVI will be processed alongside the programme amendment resulting from the Pact on Migration and Asylum. A separate amendment will be made for the Internal Security Fund, where the Commission has provided Member States with horizontal priorities at the EU level, which all Member States are

encouraged to consider and accommodate.

The following table represents the financial allocation under each Programme following the Mid-Term Review:

Pact on Migration and Asylum



The Pact on Migration and Asylum introduces new EU regulations to manage migration and establish a common asylum system, in line with European values. It builds on and revises previous proposals, offering a comprehensive strategy for migration, asylum, border management, and integration. The rules are designed to manage migration in the long term, providing EU countries with the flexibility to address specific challenges while ensuring safeguards for those in need. The Pact came into force on 11 June 2024 and shall be fully implemented after two years.

The Commission has allocated EUR 3 billion under the AMIF and BMVI for 2025-2027 to support Member States in addressing Pact-related needs, including preparatory work and the implementation and running costs in the initial years. These funds will be allocated to the AMIF and BMVI Programmes through Specific Actions, with a co-financing rate of 90% EU Share.

Member States have already been asked to justify their intended use of these additional resources in the National Implementation Plan.

Pact on Migration and Asylum (2)



Member States are now being asked to present their strategic choices on the planned use of the additional funding. This should be in coherence with the financial needs identified in the National Implementation Plan. All amendments shall be finalised by the end of 2025.

Organizations involved in activities related to the Pact are encouraged to begin planning and initiating preparatory steps for the implementation of relevant actions under the Programme, even before the amendments are approved, as retroactive eligibility generally applies from 1st January 2021.

This process requires a coordinated effort from the various organisations within the Pact and funding bodies in the Member States. Under the New Pact on Migration and Asylum, Malta has been allocated €10,865,607 under BMVI and €16,266,830 under AMIF.
