

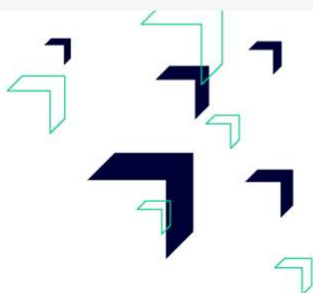

The Ministry responsible for European Funds announces the launch of calls for project proposals:

Intervention 73.1: On-Farm Non-Productive Investments (Afforestation)
The scope of the intervention 73.1 On-Farm Non-Productive Investments (Afforestation) is to support farmers to invest in afforestation on their land. Prospective applicants shall be farmers (whether natural/legal persons or partnerships) who are registered as farmers on the Department of Agriculture database (IACS) and that carry out minimum agricultural activity as defined in the guidelines.

Intervention 73.2 Off-Farm Non-Productive Investments (Afforestation)
The scope of the intervention 73.2 Off-Farm Non-Productive Investments (Afforestation) is to support investment in afforestation on public land by Government Authorities and Entities. The eligible beneficiaries for support are Government Authorities and Entities.

The On-Farm investment intervention tied to on-farm productive investments aims to fund investment in agricultural holdings, enter into, non-agriculture diversification, focusing on the territory of Malta.

Full-time bona fide established farmers (natural persons only), who:
• Are registered with Jobs Plus as farmers
• Are registered as farmers on the Department of Agriculture database (IACS)
• Have a VAT number with NACE code showing economic activity related to agriculture

The Ministry responsible for European Funds announces the launch of call for project proposal:

Intervention 78.2.1 - Knowledge Exchange and Dissemination of Information Support for the use of Advisory Services
The scope of this intervention is to provide assistance to farmers through recognised Farm Advisory Service Entities. The use of advisory services for the agricultural sector complements the purpose of measures to improve human potential, through the provision of specific advisory services, and by providing incentives to farmers to seek direct advice to address their specific situations.

Eligible Beneficiaries
Eligible applicants are Advisory Service Providers (SP) recognised as Farm Advisory Services by the Farm Advisory Service Recognition Board (FASRB) in accordance with the Guidelines for the Registration of Farm Advisory Services as per LN 99 of 2019 and as amended by LN 189 of 2024 and duly registered in the official register held by the Agriculture and Rural Payments Agency.

The end beneficiaries who shall be the recipients of advice must be farmers.

Calls for Proposals



Since December 2024, **4 calls** for proposals were issued.

Under LEADER, the three LAGs launched **11 calls** for proposals on an **open rolling basis**.



Information Sessions were promoted on our social media platforms, FONDI.eu portal and sometimes even on Newspapers.

Calls tied to LEADER were promoted on the LAGs social media platforms, radio programmes as well as newspaper adverts.

An additional 7 information sessions were organised by Local Action Groups, in collaboration with Fondi.eu and SEM.



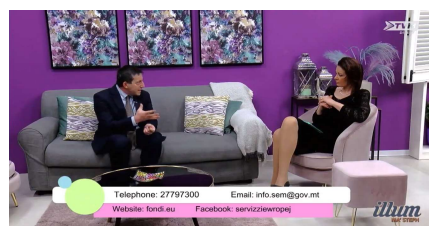

Visit by Commissioner Christophe Hansen

- 13 October visit was part of the Commissioner's tour of all Member States to discuss the **future of agriculture and local challenges**.
- Met with the Maltese Agriculture Consultative Council to discuss the **Commission's proposal for the new Common Agricultural Policy (2028–2034)**.
- Held talks with Prime Minister Robert Abela.
- Attended the inauguration of the new **Food Safety and Security Authority of Malta**, which will oversee national food safety and supply chain security.
- Together with Agriculture Minister Anton Refalo, visited a **dairy farm in Swieqi** - a modern, EU-supported enterprise run by a young farmer.

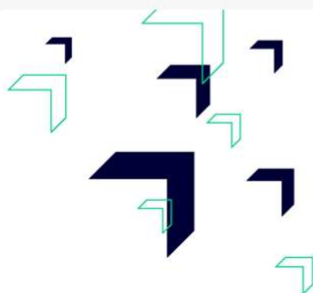
