

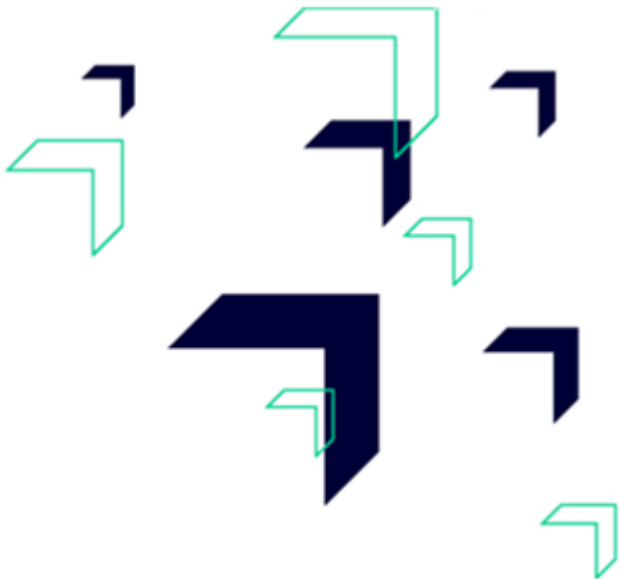

Monitoring - Indicators

The Evaluation Unit carries out indicator checks on a sample of indicators reported biannually by the MA in the Transmission of Data. Checks include plausibility assessments and verification of achieved values, in accordance with the methodology established for each indicator.

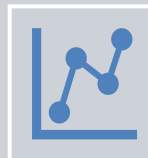

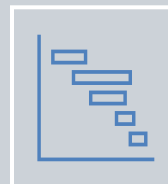

Update on the status of the Enabling Conditions

Enabling Conditions Monitoring

- The Strategy & Programming Unit, within the SID, takes on the **role of monitoring** the fulfilment of the Enabling Conditions.
- SID has recently introduced a new online tool to monitor the Enabling Conditions more effectively and efficiently. This tool is now fully integrated into the Structural Funds Database and has successfully passed all internal testing, including trials on the live environment.
- Since the last MC, a pilot exercise was carried out whereby selected ministries were given the opportunity to test the system in real conditions.
- A comprehensive training session for all users took place on 20th November 2025 with a total of 30 participants.
- Last week, the first digital monitoring exercise was launched, making the system fully operational.

- **All enabling conditions have been fulfilled with the exception of the enabling condition related to Transport.**
- The National Transport Masterplan 2030 and its accompanying Strategic Environmental Assessment (SEA) Environmental Report are currently undergoing a public consultation which will close on the **9th December 2025**.
- The official notification of fulfilment to the CION will be transmitted once the plan is published.

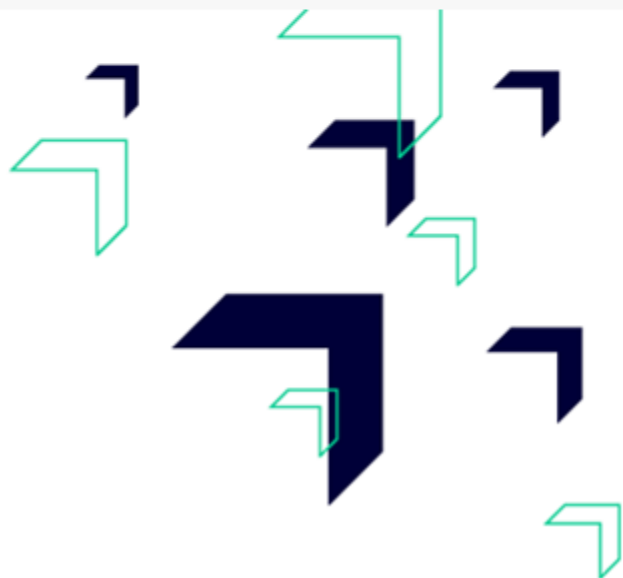
