

## Eligible Organisations for European School Alliances

**Eligibility category (1):** State, Church and Independent schools providing general education at pre-primary, primary or secondary level, including organisations providing early childhood education and care

Eligible education programmes and activities	Implementing organisations
Pre-primary education and early childhood education and care	Child care centres and kindergartens schools.
Primary education	Primary schools, International Learners
Secondary general education	Secondary schools, visual and performing arts schools, music schools, hospital and health schools, vocational and educational schools, national sports school, alternative learning programme.
Post-secondary schools	General post-secondary schools.
